
TO WHOM SO EVER IT MAY CONCERN

In compliance of the Ministry of Environment and Forest (MoEF) Government of India's letter No. 11-9/98-FC (pt.) dated 3rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act 2006 ('FRA' for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated 5th February 2013 wherein MoEF issued certain relaxation in respect of linear projects, it is certified that 0-21-83 hectare of forest land proposed to be diverted in favour of Director Technical Education Professional & Industrial Training Institute Sundernagar Distt. Mandi (HP) for construction of Road Technical Institute, Dalash in Kullu district falls within jurisdiction of Gram Panchayat, Dalash village in Anni Tehsil.

It is further certified that:

- (a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire 0-21-83 hectare of forest area proposed for diversion. A copy of records of all consultations and meetings of the Forest Rights Committee(s), Gram Sabha(s), Sub Division Level Committee(s) and District Level Committee are enclosed as annexure A to annexure D.





In compliance of the Ministry of Environment and Forest (MoEF), Government of India's letter No. 11-9/98-FC (pt.) dated 3rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA' for short) on the forest land proposed to be diverted for non-forest purposes, it is certified that 1-65-03 hectare of the forest land proposed to be diverted in favour of Director Technical Education Professional & Industrial Training Institute Sundernagar Distt. Mandi (HP) for construction of Building Technical Institute, Dalash (Anni) in district Kullu which falls within jurisdiction of Gram Panchayat, Dalash in Tehsil, Anni.

It is further certified that:

- (a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire 1-65-03 hectare of forest area proposed for diversion. A copy of records of all consultations and meetings of the Forest Rights Committee(s), Gram Sabha(s), Sub Division Level Committee(s) and District Level Committee are enclosed as annexure A to annexure D.
- (b) The proposals for such diversion (with full details of the project and its implications, in vernacular/ local language) have been placed before each concerned Gram Sabha of forest dwellers, who are eligible under the FRA.
- (c) The each of concerned Gram Sabha(s) has certified that all formalities/ processes under the FRA have been carried out and that they have given their consent to the proposed diversion and the compensation and ameliorative measures, if any having understood the purpose and detail of proposed diversion. A copy of certificate issued by the Gram Sabha of Dalash villages (s) is enclosed as annexure C to annexure D.
- (d) The discussion and decision on such proposals had taken place only when there was a quorum of minimum 50% of the members of Gram Sabha present.
- (e) The diversion of forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the Gram Sabhas have given their consent to it;
- (f) The rights of Primitive Tribal Groups and Pre-Agriculture Communities, where applicable have been specifically safeguarded as per section 3(1)(e) of the FRA.
