- (1) I invite kind attention to the subject and references cited. In the reference 2<sup>nd</sup> cited, the Divisional Forest Officer, Kadapa has addressed a letter to the Chief Conservator of Forests, Kurnool circle, Kurnool and requested the Revenue Department about the status of the Un Reserve Land / Hill areas (list enclosed), which are located adjoining to Sri Lankamalleswara Sancturary and Sri Penusila Sanctuary in the Tiger Corridor Region. Further, it is requested to verify the possibility of alienating these lands under Compensatory Afforestation in lieu of diversion of forest lands for the developmental proposals in the State of Andhra Pradesh.
- (2) Accordingly, in the reference 3<sup>rd</sup> cited, the same was forwarded to the Tahsildars concerned duly marking a copy to all Revenue Divisional Officers in this district and requested to take up the Joint inspection along with Forest Officials and to identify suitable land for Compensatory Afforestation in lieu of diversion of forest lands for developmental purpose and submit report along with connected records to this office immeidately for taking further action in this matter. Also, on 09.10.2015,

I have directed the RDOs and DFOs to expedite and give reports as per the directions in the ref. 1<sup>st</sup> cited.

- (3) As per the reports submitted by the RDOs, Kadapa / Jammalamadugu / Rajampet regarding the Government lands available for compensatory afforestation adjoining to Sri Lankamalleswara Sanctuary and Sri Penusila Sanctuary in Tiger Corridor in YSR District is shown below:
