In reference to our forest diversion proposal submitted earlier on Ministry of Environment Forest and Climate Change portal (Proposal No FP/AP/TRANS/27462/2017 dated 23<sup>rd</sup> August 2017) for 18.86Ha of forest land in Guntur Forest division for construction of Warangal (New) - Chilakaluripeta 765kV D/C transmission Line constructed by Warora Kurnool Transmission Limited, we require a certificate from your good office in accordance to Recognition to Forest Right Act 2006.

We have submitted a proposal for diversion of 18.86Ha of forest land in Madinapadu RF and Janapadu RF under Guntur forest division in Guntur District. This is the minimum forest land which cannot be avoided. The detail land schedule is attached herewith. As per MoEF&CC guideline F.No. 11-9/98-FC (pt.) dated 5<sup>th</sup> July 2013 and F.No 11-9/98 –FC(pt.) dated 5<sup>th</sup> February 2013, a certificate from your good office is required in the specified format (Form I for Linear Project) along with the evidence for having initiated and completed the process of settlement of rights under the schedule Tribes and other Traditional Forest Dwellers (Recognition of Forest Right ) Act 2006.

In view of above, we need your kind support for obtaining the required certificate at the earliest which may enable us to expedite the process of forest diversion and enable us timely completion of inter-state transmission line project "Warangal (New) - Chilakaluripeta Transmission line associated with Warora Kurnool Transmission Limited (WKTL) as this is an important project. This project is monitored by Ministry of Power, Govt. of India and is a Project of National interest.
