Further you are requested to please implement activities with a cost of Rs. 10.20 lakh which are to be implemented by the User Agency immediately as per approved Site specific wildlife conservation plan.

Besides the above you are requested to please submit the following undertakings for future compliance.

- 1- Undertaking regarding revision of Site specific wildlife conservation plan after 5 years and to contribute towards the revised cost of the conservation plan till the project period.
- 2- Undertaking regarding, the project proponent has to prepare and submit the Conservation Plan for the next 10 years. If there would be need for SSWLCP after

expiry of the present plan period and said plan will be submitted at least one year before the expiry of the present Conservation Plan and deposit the outlay amount upon its approval. In case of delay, it will be dealt as per law for violations of FCAct, 1980 and Environment (Protection) Act, 1986.

3- Undertaking regarding to pay the differential cost in case of enhanced wage rate at the time of implementation of the plan.
