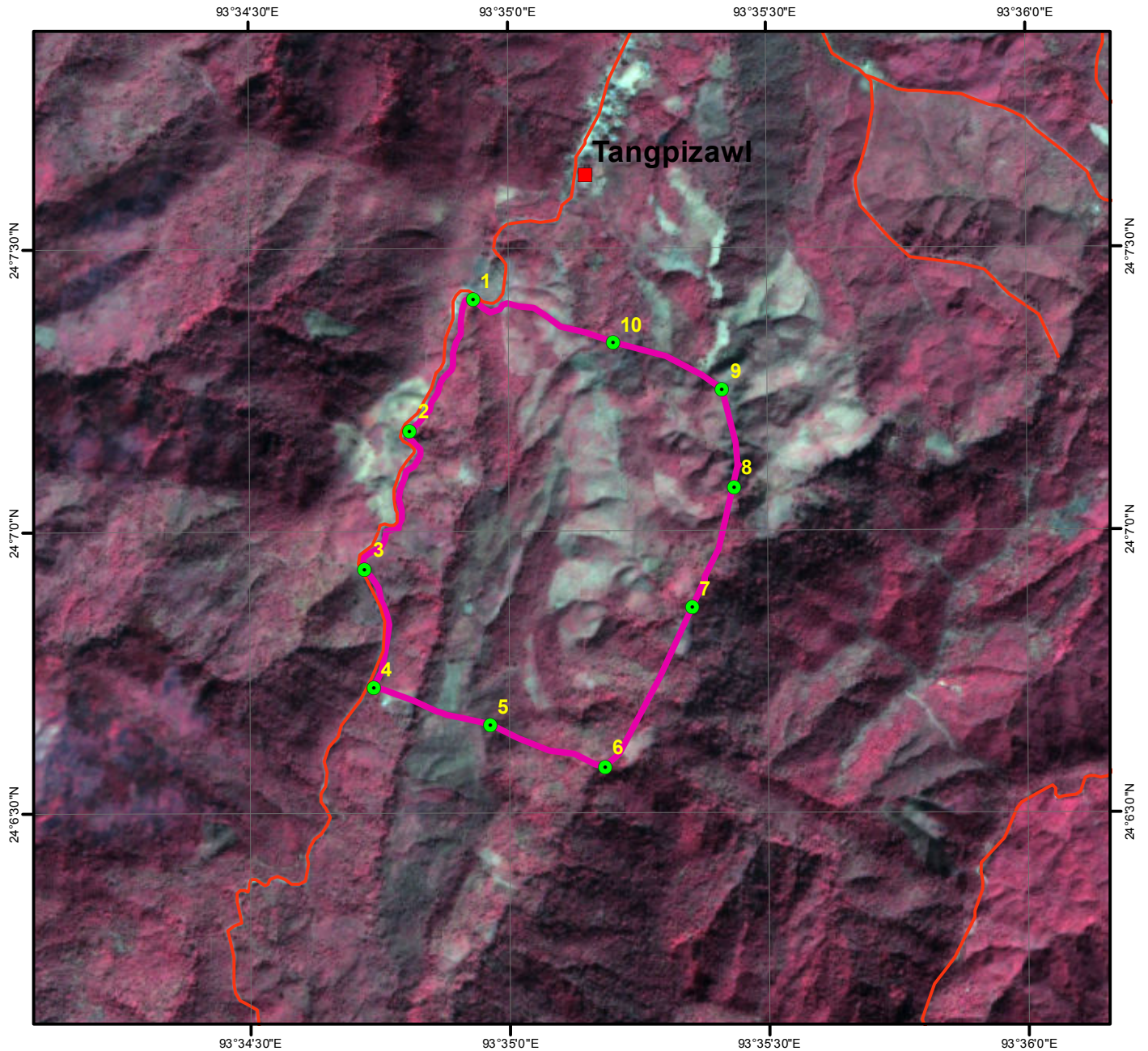




Map of CA Plantation at Tangpizawl Village

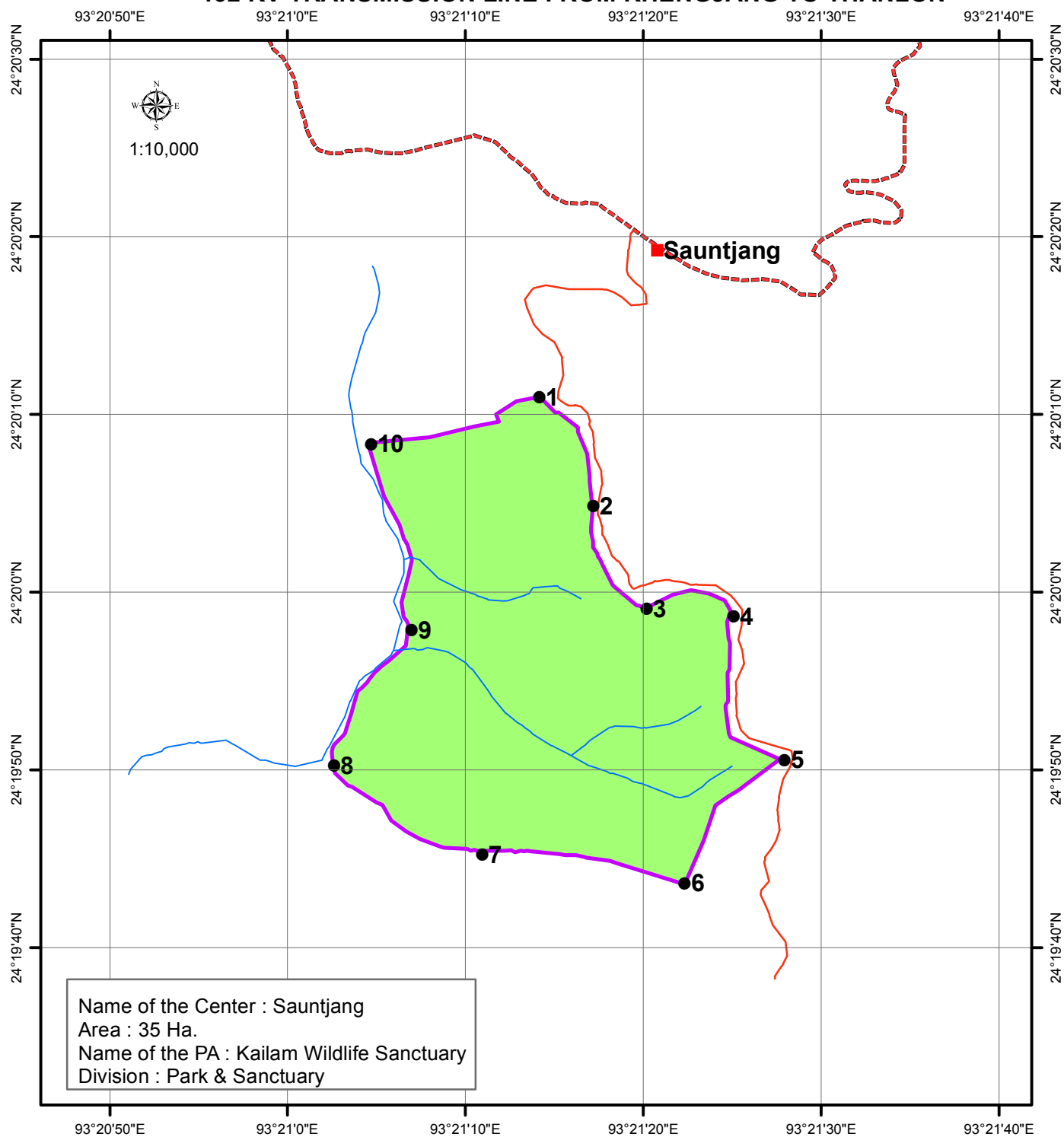

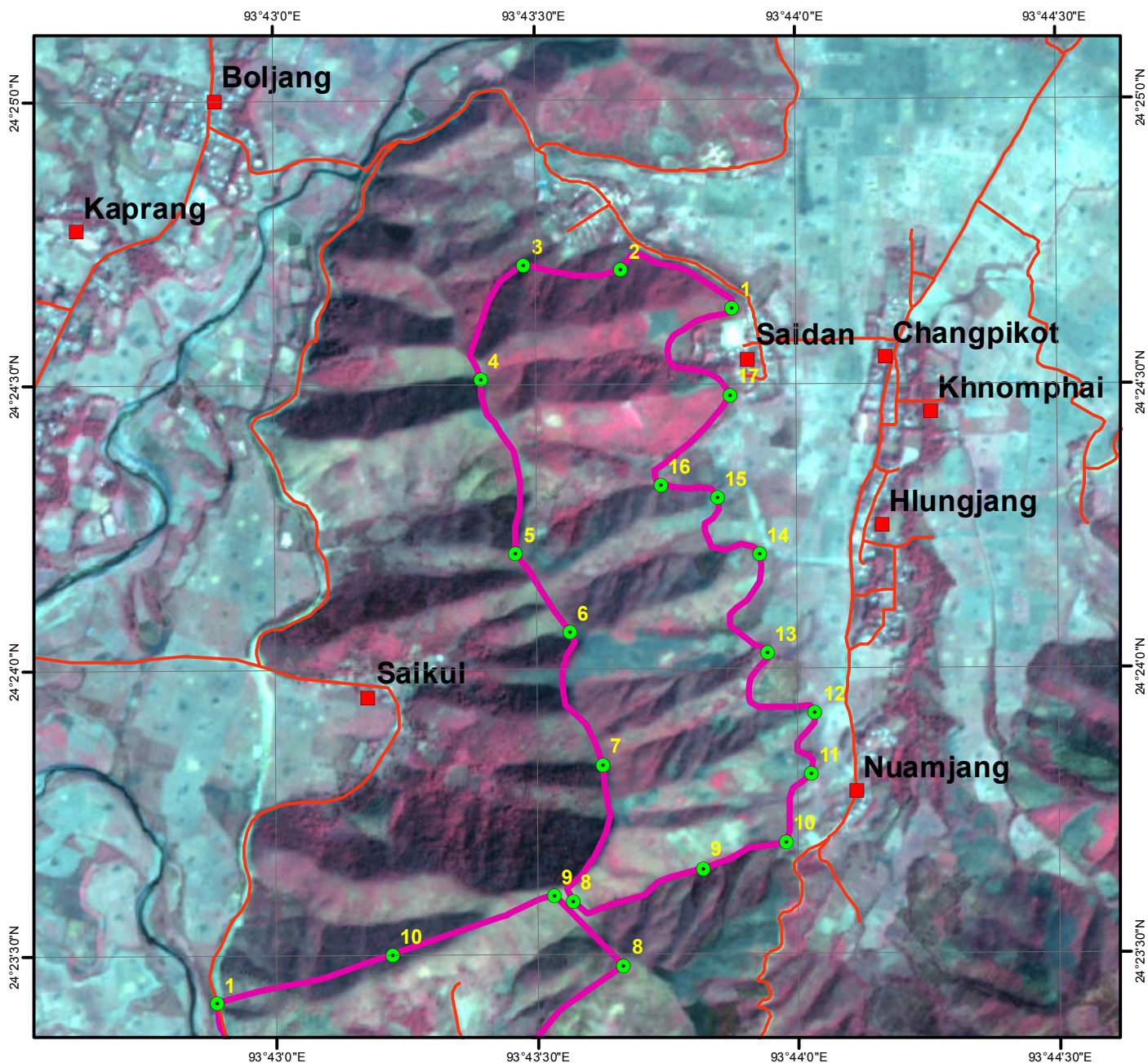
