

- ✓ 6. Undertaking for demarcation and construction of boundary pillars in Non Judicial Stamp paper.
7. Undertaking for raising afforestation equivalent to one and half time of safety zone area (for stone mahal/quarry area) in Non Judicial Stamp paper.
