It is informed that, in the reference 1st cited, the Government of Andhra Pradesh has issued Stage-I approval for Diversion of 1.60 ha of forest land in Compartment no.910 of Sankaram RL, Visakhapatnam Division for formation of road from Magathapalem to Vedurapalli in favour of Executive Engineer, PIU (PR), Paderu with certain conditions. I. (a) Procedure for e- challan generation:

- On issue of this demand notice, the user agency shall log in to Forest Clearance portal **forestsclearance.nic.in** to generate e-challan and make payment against the demand.
- Agency shall fill all the details as per the format provided in the portal and submit to Nodal Officer for verification.
- Once it is verified by Nodal Officer, Agency can generate e-challan from the portal.

I. (b) Procedure for Payment through RTGS:

- For payment through RTGS, the representative of the agency should visit his bank branch (RTGS enabled) of a Bank of his choice along with printed e-challan with an Account Number printed on it.
- While tendering the e-challan at the bank, the agency must ensure that the unique account number mentioned in the challan should be correctly mentioned as the account number in which funds to be remitted.
- Upon executing the RTGS by the sender/ remitter bank, the amount collected will be credited to relevant CAMPA state account with the Bank on real time basis.

Further, it is informed that, if any payment is made by any other method, the same shall not be considered for compliance towards Stage I /II and also submit the receipts along with the compliance report as the conditions stipulated in the references cited point wise for onward submission to the Prl.Chief Conservator of Forests (HoFF) A.P. Guntur for further action in the matter.
