In compliance of the Ministry of Environment and Forests (MoEF) Government of India's letter No. 11-9/98-FC (Pt) dated: 3rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (FRA for short) on the forest land proposed to be diverted for non-forest purposes, it is certified that 1.00 (one) hectares of forest land proposed to be diverted in favour of **Ekhelia Stone Mahal No. 2 in Milmilia R.F.** for collection Boulder/Stone/Sand in Kamrup District does not fall within jurisdiction of any forest village (s) in (NA) tehsils.

It is further certified that:
