Sub: APFD – F(C) Act, 1980 - Diversion of **1.85 Ha.** of Forest Land in Narsipatnam division for providing BT Road from Pedduru to Seetharampuram villages Via Rolangi of Chintapalli Mandal, Visakhapatnam District in favor of Executive Engineer, R&B Division, Paderu – In – principle **(Stage-I) approval** accorded– Fulfillment of conditions for final approval - Demand notice issued – Reg.

The Prl. Chief Conservator of Forests(HoFF), A.P., Hyderabad vide reference cited above, while communicating that in-Principle approval of the proposals by the Govt. of Andhra Pradesh for while according **Stage-I approval** for diversion of **1.85 Ha.** of forest land required for providing BT Road from Pedduru to Seetharampuram villages Via Rolangi of Chintapalli Mandal, Visakhapatnam District in favor of Executive Engineer R&B Division, Paderu in Narsipatnam Forest Division has issued instructions for raising the demand with the User Agency on the amount payable.

Regarding the Narsipatnam Division based on the proposals submitted for diversion of Forest land. The User Agency is hereby requested to pay the following amount.

Sl. No.	Details of the Conditions as per the G.O.Rt. No.303, EFS&T (Section-II) Dt. 05.11.2015	Details of the conditions to be fulfilled by the User Agency
1.	The State Government shall charge the Net present value of the forest area diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated: 28-3-2008 and 9-5-2008 in IA Nos: 826 in 566 WP (C) N: 202/1995 and as per the guidelines issued by Government of Andhra Pradesh vide Go.Ms.No.124,EFS&T(For-I) Department Dated: 27-7-2010	The User Agency shall deposit the NPV of Rs.11.581 lakh. (Rs.6.26 lakh per Ha.)

In addition to payment of NPV the following conditions are imposed to attend by the User Agency to submit for getting Stage-II clearances.

1. The demarcation of the forest area proposed for diversion shall be carried out by erecting cement concrete pillars duly numbered at an Interval of 20 meters at the cost of user agency.
2. To furnish an undertaking agreeing to pay Additional amount of the Net Present Value (NPV) of the diverted forest land, if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future.
3. The user agency is also requested to fulfill the other conditions as per the instructions of the G.o.I, MoEF & C.C, letters Dated. 13-5-2011, 16-6-2011 and 10-12-2012 shall also be complied with by Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, Hyderabad and user agency with which they are concerned.
