Sub:- R&B Dept – Diversion of 4.971 Ha of Forest Land in Nizamabad Circle – For Widening of Single lane to Double lane for connecting mandal head quarter to district head quarter for Sirikonda-Vemulawada road from km.0/0 to 20/5 in Nizamabad District. - Submission of proposals -Initiation of Land Acquisition process -Request – Reg.

It is proposed to take up Widening of Single lane to Double lane for connecting mandal head quarter to district head quarter for Sirikonda-Vemulawada road from km.0/0 to 20/5 in Nizamabad District. The Government have accorded Administrative Sanction for an Amount of 25.00 Crores vide G.O.Rt.No.127, Dt. 27-11-2014.

The road of Sirikonda – Vemulawada road is identified as Major District road. This road starts at Km.0/0 at Sirikonda Mandal head quarters, which is identified as one of the high density traffic corridor under MDR and ends at Vemulawada, having a total length of 20.50 kms. The entire road is having Black topped surface. As per the road statistics the total length of the road is 20.50 Kms. i.e, Single Lane from Km.0/0 to 20/5.

There is a famous temple "sri Rajarajeshwari temple" is located in Vemulawada. This is the shortest route for the pilgrims of Nizamabad District. This road is being used by the people of Nizamabad as well as Karimnagar District. This road is having connectivity for inter district transportation to Karimnagar district, due to shortest route to Karimnagar district for the people coming from Karimnagar as well as Nizamabad districts by a considerable saving in time and fuel.

The reach of Sirikonda to Vemulawada road from Km.3/750 to 8/200 both sides are under the Forest Jurisdiction of Kamareddy Division. The Telangana state Government have taken policy decision to improve the roads from Single lane to Double lane connecting from Mandal headquarter to District head quarters . After improvements of this road, it will provide good connectivity from Nizamabad District head quarter to Karimnagar district head quarter. There by a considerable saving in time and fuel. Hence it is very much vital to widen the road to smooth flow of traffic.

A detailed Differential Global Position Survey is carried out in the above reach along with the forest section officers. As per our requirement the total extent of Forest Land is arrived as 4.971 Hectares in Jurisdiction of Kamareddy forest Division, for which linear diversion of forest land is required.

The proposals are submitted as per the guide lines issued under Forest (Conservation) Act1980, the project for road construction will be processed in their entirety. Hence the proposals



for Acquisition of Forest Land is prepared in the Division Kamareddy forest Division in the prescribed format, drawing showing the improvements, Longitudinal section and cross section along with Forest map showing the area of land are here with enclosed for kind perusal. Hence, I herewith submit the proposals under Forest (Conservation) Act, 1980 with the following enclosures.


It is, therefore, requested the Principal Chief Conservator of Forests, Aranya Bhavan Hyderabad, kindly to initiate the process of Forest Land Acquisition and also requested to pass necessary orders to the concerned to start the field survey as early as possible for submitting same to the Government for according approval of linear diversion of forest land for geometrical improvements of road in reserve forest.
