**TO WHOM IT MAY CONCERN**

In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No. 11-9/98-FC (pt.) dated 3<sup>rd</sup> August/2009 wherein the MOEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA', for short) on the Forest land proposed to be diverted for non-forest purpose, it is certified that 5.00 hectares of Forest land proposed to be diverted in favour of **Baghara Stone Quarry** (name of user agency) for Stone Quarry (purpose for diversion of Forest land) in Morigaon district falls within jurisdiction of **N/A** village (s) in **Morigaon** tehsils.

**It is further certified that:**

- (a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire **NIL hectares** of Forest land proposed for diversion.
