I am to enclose herewith a copy of the letter cited along with statutory proforma proposal under Forest (Conservation) Act, 1980, submitted by the Principal Chief Conservator of Forests (Head of Forest Force), Andhra Pradesh for diversion of 0.75 Ha of forest land in Compt. No.67 of Ambapouram RF, Nellore Division for forming CC approach road from Akkacheruvupadu to Nellore – Podalakur Road in favour of Commissioner, Nellore Municipal Corporation, Nellore.

- 2. I wish to inform that the user agency i.e. the Commissioner, Nellore Municipal Corporation, Nellore has submitted justification stating that the road is proposed to provide the transport facility to NTR colony and local resident of Akkacheruvupadu through Ambapuram RF. There is no alternative suitable land except the proposed approach road. The RF area is unavoidable and barest minimum. The user agency has submitted an undertaking to bear the cost of raising and maintenance of compensatory afforestation, payment of Net present Value (NPV), additional NPV and tree extraction charges etc. The Principal Chief Conservator of Forests has reported that the user agency has not violated the provisions of Forest (Conservation) Act, 1980. The proposal involves felling of 1370 Eucalyptus trees raised by AP Forest Development Corporation Ltd., Nellore.
- 3. The District Collector, SPSR Nellore District has issued necessary certificates under Scheduled Tribes & Other Traditional Forest Dwellers (Recognition of Forest Rights) Act,2006, as stipulated by the Ministry of Environment, Forests & Climate Change, Government of India, New Delhi vide Lr.No.11-9/1998-FC (pt), dt.05.02.2013, in the prescribed format (Form-I) for evidences for having initiated and completed the process of settlement of rights. The field officers concerned and the Principal Chief Conservator of Forests (Head of Forest Force), have recommended the proforma proposal in Part-II, III and IV respectively. The recommendation of the State Government in the proforma proposal in Part-V is enclosed herewith.
- 4. I request you to obtain and communicate the approval of Government of India, Ministry of Environment, Forests & Climate Change, under Section 2 of Forest (Conservation) Act, 1980, for diversion of 0.75 Ha of forest land in Compt. No. 67 of Ambapouram RF, Nellore Division for forming CC approach road from Akkacheruvupadu to Nellore Podalakur Road in favour of Commissioner, Nellore Municipal Corporation, Nellore, at an early date.
