**Sub: Diversion of 0.0165 ha of forest land in favour of Blue Meadows Co-Operative Housing Society, Pune for laying of underground water pipeline for drinking water and agriculture purpose at Village-Kuravati, Tal. Velhe in Pune District in the State of Maharashtra.**

Sir,

The undersigned is directed to refer to the Government of Maharashtra's letter no. FLD-2022/CR-115/F-10 dated 21.06.2022 and APCCF & Nodal Officer (FCA), Maharashtra Letter No. Desk-17/Nodal/Pune/ID-12766(20)/2594/2021-22 dated 03.03.2022 on the above subject seeking prior approval of the Central Government under Section-2 of **Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980**. After careful examination of the proposal of the State Government, 'in-principle' approval was accorded by the Central Government vide its letter of even number dated 24.01.2023. The Addl. PCCF and Nodal Officer (FCA), Government of Maharashtra, vide his letter no. Desk-17/FCA-S2/PID-30860/Pune/2024-25/1595 dated 11.10.2024 submitted compliance report and requested to grant final approval to the proposal.

After careful consideration of the proposal and compliance report, I am directed to convey the Central Government's 'final approval' under Section- 2 of the **Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980** for diversion of **0.0165 ha** of forest land in favour of Blue Meadows Co-Operative Housing Society, Pune for laying of underground water pipeline for drinking water and agriculture purpose at Village-Kuravati, Tal. Velhe in Pune District in the State of Maharashtra subject to the fulfilment of the following conditions:

- i. Legal status of the forest land shall remain unchanged;
- ii. The boundary of the. diverted forest land shall be suitably demarcated on ground by the **State Forest Department at the cost of the User Agency;**




- iii. Compensatory afforestation shall be taken up by the Forest Department over **1.00 ha** degraded forest land in Gut No. 31 at Village- Tungarli, Taluka- Maval, District- Pune from the amount which has already been realized from the User Agency. As far as possible, a mixture of local indigenous species along with 10% RET species of Pune District shall be planted and monoculture of any species may be avoided. Atleast one water body shall be constructed in the form of tank/ stop dams etc if the same are not available in the area or in nearby vicinity. Further, if existing tanks/ stop dams are available and needs desilting/ repair; same shall be carried out to meet the water requirement of wild animals throughout the year;
- iv. Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency;
- v. **No tree felling or cutting shall be permitted under instant proposal;**
- vi. The State Government, Maharashtra/ Nodal Officer (FCA), Maharashtra shall ensure settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (No. 2 of 2007) before issuing an order for handing over of forest land to the User Agency;
- vii. To improve the Forest/ Tree cover and to reduce pollution in the State, as mandated in National Forest Policy, 1988 and Environmental (Protection) Act, 1986 respectively, the User Agency with involvement of Joint Forest Management Committees (JFMC's) and in consultation with local DCF shall raise at least 500 seedlings of forestry species along with bamboo, fruit bearing, medicinal, ornamental and indigenous/local for 10 years. At least 50% of seedlings shall be planted in the vicinity of project area and remaining 50% of seedlings shall be distributed among villagers as per choice of villagers. The concerned JFMC's shall maintain record of plantation/ seedling distribution to villagers;
- viii. **The pipeline shall be laid down 1.5 meter below the ground and after lying down of pipe line the ground will be leveled;**
- ix. The User Agency shall provide water to the Forest Department as per their requirement for irrigating plantation nearby and for drinking purpose for wild animals;
- x. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable;
- xi. The layout plan of the proposal shall not be changed without prior approval of Central Government;
- xii. No labour camp shall be established on the forest land;






- xiii. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel;
- xiv. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work;
- xv. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less;
- xvi. The Forest land shall not be used for any purpose other than that specified in the project proposal and **diverted forest area shall not exceed 0.0165 ha;**
- xvii. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India;
- xviii. Violation of any of these conditions will amount to violation of **Van (Sanrakshan Evam Samvardhan) Adhiniyam 1980** and action would be taken as per the provision of **Adhiniyam** and rules/guidelines issued there under;
- xix. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife;
