ORDER

In the reference 2nd read above, the District Forest Officer, Bhadradri-Kothagudem district has stated that the following Government lands have been identified at Puligundala Village at Dummugudem mandal and Bhumullanka and Ricepeta villages in Cherla Mandal for allotment Compensatory Afforestation by the Divisional Forest Officer, Bhadrachalam.

2) It is further stated that vide reference 1st read above, orders have been issued for allotment of revenue land for diversion of forest land under SRLIP at Puligundala village in respect of Sy.No.1/1 of Cherla Mandal for an extent of Ac.20.040 Ha (49.53 acres) in and out of Ac.57.17 Acrs and land to an extent of Ac.127.347 Ha has been allotted in respect of Sy.No.12,117 at Ricepeta and Bhumullanka in and out of Ac.130.347 Ha. Thus there is an excess of Government land to an extent of Ac.10.00 is available as shown above, which is scattered and rocky and having natural growth and suitable for Compensatory Afforestation for diversion of forest land for establishment of CRPF (Police Establishment-Border posts) in Pusugudem village of Cherla mandal. He therefore requested to allot land to an extent of


Ac.10.00 available so that the establishment of CRPF Camp at Pusuguppa Village of Cherla Mandal, can be processed.


- 3) In the circumstances stated above, it is hereby ordered to allot the following Government lands to the Forest Department for Compensatory Afforestation pending finalization of transfer proposals as the land is said to be scattered, rocky and having natural growth and suitable for C.A. pending finalization of regular transfer proposals.

- 4) The District Forest Officer, Bhadradi Kothagudem is directed to submit necessary requisition for allotment of said Government land in the prescribed proforma to this office for issuance of regular allotment orders.

- 5) The Tahsildar, Cherla and Dummugudem mandals are directed to hand over the land in Sy.No.1/1 for an extent of Ac.7.00 situated at Puligundala village and Ac.3.00 in Sy.No.12 and 117 of Bhumullanka and Ricepeta villages of Cherla Mandals respectively, said to be scattered and rocky to the Divisional Forest Officer, Bhadrachalam under cover of panchanama and report compliance. They are further directed to submit regular transfer proposals following due procedure of law through the Sub Collector, Kothagudem within one month and also make necessary corrections in on-line Dharani Pahani with the approval of Collector and District Magistrate, Bhadradi-Kothagudem and keep in the POB of concerned villages.
