It is proposed to take up Formation of approach road to main work “Construction of HLB across Manjeera river from Dharamreddy to Muddapoor via Venkampally road PR road in Nizamabad District(Present Kamareddy District)”. The Government have accorded Administration Sanction for Amount of 35.00 Crores vide reference 1st cited.

For this work diversion of forest area required. A detailed Differential Global Position Survey is carried out along with the forest section officers. As per our requirement the total extent of Forest Land is arrived as 2.121 Hectares in Jurisdiction of Kamareddy forest Division, for which linear diversion of forest land is required. Detailed DGPS survey conducted was submitted vide reference 2nd cited. The DGPS survey raw-data submitted was verified and authenticated vide reference 3rd cited.

Further, it is submitted this road forms approaches to the High level bridge constructing across Manjeera river, this is only short route available to connect the Bridge. This road enters in to the forest area at km 0/446 and leads up to km 1/116 for a length 720m on the exiting single lane road in Reserve Forest Area and the road diverts from existing road at km 1/116 and leads to Bridge location.

The proposals are submitted as per the guide lines issued under Forest (Conservation) Act 1980, the project for road construction will be processed in their entirety. Hence the proposals for Acquisition of Forest Land is prepared in the Kamareddy forest Division in the prescribed format, drawing showing the improvements, Longitudinal section and cross section along with Forest map showing the area of land are here with enclosed for kind perusal. Hence, I herewith submit the proposals under Forest (Conservation) Act, 1980 with the required enclosures. It is, therefore, requested the Principal Chief Conservator of Forests, Aranya Bhavan Hyderabad, kindly to initiate the process of Forest Land Acquisition and also requested to pass necessary orders to the concerned to start the field survey as early as possible for submitting same to the Government for according approval of linear diversion of forest land for geometrical improvements of road in reserve forest.
