National Highways Authority of India (Govt. of India) has taken up the work of four laning from Goa-Karnataka Border to Kundapur section of NH-66 (formerly NH-17) under NHDP Phase-III. The work has been awarded to the Concessionaire M/s. IRB West Coast Tollway Pvt. Ltd. on BOT basis. The project work has been commenced in March-2014 and the period of completion of the Highway work will be 910 days from the date of commencement of the work. The Concessionaire is required to establish quarries and mobilize plants and machineries for execution of the work.

2. Now, our Concessionaire M/s. IRB West Coast Tollway Pvt. Ltd., Mumbai (EPC M/s. Modern Road Makers Pvt. Ltd.) have informed vide their letter referred above that, their EPC Contractor M/s. Modern Road Makers Pvt. Ltd. have taken a land of 19 acres in Sy.no. 310/1 & 310/2 of Shetgeri village, Ankola taluk, Uttara Kannada District on lease for a period of 4 years for the purpose of extracting Boulders to be used for up-gradation and 4/6 laning of Goa-Karnataka Border to Kundapur section of NH-66 (formerly NH-17) (Km. 93.700 to Km. 283.300).

3. Further, Shri. Raghunath Acharya representative of Concessionaire and EPC contractor M/s. Modern Road Makers Pvt. Ltd., has been hereby authorized to upload the documents for online registration of application for using the access road, which passes partially through forest land, lead to quarry in Survey no. 310/1 & 310/2 of Shetgeri village, Ankola Taluk, Uttara Kannada District taken on lease by the EPC Contractor for extraction of boulders for the development of subject project Highway, which is of National Importance.
