Sub: - Construction of road from Devakkapet to Thatipally road from km.0/0 to 10/0 in Nizamabad District – Submission of proposals – Initiation of Land Acquisition process – Request – Regarding.

The Government of Telangana state accorded Administrative sanction vide Ref. 1st cited for an amount of Rs. 920.00 Lakhs for the work of "Construction of road from Km.0/0 to 10/0 in Nizamabad district".

The road from Devakkapet to Thatipally road from Km.0/0 to 10/0 is an important Other District road having the total length of 10.0 KMs (i.e., Km. 0/0 to 5/0 comes Balkonda constituency and Km. 5/0 to 10/0 in Nizamabad Rural constituency) and the existing road is a single Lane earthen road. The road originates at Km. 14/7 of Mendora crossing to Rudrangi via Manala road and ends at Km.19/0 of Sirikonda-Vemulawada road which is identified as one of the high density traffic corridor under other district roads category. This road is being used by the people from two Mandals viz., Bheemgal and Sirikonda.

This road provide better route for the farmers to transport their agriculture products to markets at Nizamabad and Rajanna Siricilla district and the road is nearest to Devakkapet and Thatipally.

The road is passing through forest reach from Km. 1/3 to 9/529.23(Bheemnagar forest reach) the above forest reach is under the forest jurisdiction of Nizamabad division.

It is proposed to take up road construction of BT road on existing earthen road. As such the permission of the forest authorities is required. DGPS raw-data of the forest area proposed for diversion has been verified and authenticated by PCCF Office vide reference 2nd cited for an extent of 4.9375 Ha (length 8229.23 M & width 6.00 M).

Accordingly, as per the instructions contained in the reference 2nd cited, proposals in seven (7) sets alongwith all relevant enclosures for diversion of forest land to an extent of 4.9375 Ha (or say) 4.938 Ha is submitted herewith in both online and offline mode.

It is therefore requested the Principal Chief Conservator of Forests, Aranya Bhavan Hyderabad, kindly initiate the process of Forest Land Acquisition and accord forest clearance at an early date, so as to complete the project in a time bound manner and in the coming working season.
