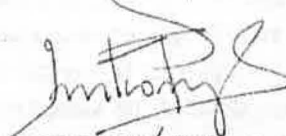

- (1) It is certified that, the complete process for diversion and settlement of rights under the Scheduled Tribes & Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 has been carried out for the entire Forest area of 147.06 Ha. proposed for diversion for road widening project of National Highways Authority of India, PIU-Mangalore in villages - Majali, Arga, Amdalli, Harwada, Aversa sakalabena, Algeri, Baleguli, Shirkuli, **Shedgeri**, Bole, **Shetgeri**, Belse, Shirur and Kadsani in Karwar Forest Division & Ulvare, Andie, Belale, Moraba, Betkuli, Kurigadde, Bargi, Yetthinabail, Mirjan, Anthravalli, Divgi, Manaki, Kumta, Kalbagh, Davgiri, Holegadde, Honnavar, Kasarkod, Kelegnur, Gunavanthe, Manki, Tumbabeelu, Sulebeelu, Bailur, Mavalli, Kaikini, Venbkatapura, Hebel, Puravarg, Haddin, Yelvedikavur and Belke in Honnavara Forest division.
