2. Representation received from Gottipati Ravi Kumar, M.L.A., 224-Addanki Assembly constituency, Prakasam District along with the letter of Hon'ble Minister of state for Textiles, dated: 15.02.2012.
3. From the General Manager, South Central Railway, Secunderabad, Lr.No.W.Con.338/G/106, dated: 18.07.2012.

ORDER:

In the reference 1<sup>st</sup> read above, the Government of Andhra Pradesh has conveyed the commitment for the 50% cost sharing for construction of new BG Line between Nadikudi - Srikalahasti (309 Km).

2. In the reference 2<sup>nd</sup> read above, Public Representatives have requested the Government to consider the change of alignment of the proposed new B.G Railway line between Nadikudi - Srikalahasti (via) Addanki to meet the needs of the people of Addanki area in Prakasam District.

3. In the reference 3<sup>rd</sup> read above, the General Manager, South Central Railway, Secunderabad has requested the Government to providing land free of cost and to bear 50% of remaining cost of the project by the Government of Andhra Pradesh.

4. Government, after careful consideration, hereby agree in principle for land free of cost in addition to bear 50% cost sharing for construction of new BG line between Nadikudi - Srikalahasti and for change of alignment Nadikudi - Srikalahasti via Addanki for additional distance 49 Kms with additional cost of about Rs.208 Crores.

5. Therefore, the Ministry of Railways may be requested for taking necessary action for changing the alignment of Nadikudi - Srikalahasti via Addanki.

6. This order issues with the concurrence of Finance Department vide their U.O. Note No.17241/640/Exp.PW-II/13, dated: 18.07.2013.
