**DEMAND NOTICE**

Sub : Diversion of 1.737 Ha. of forest land in Singanapalli –A RF of Nellore Division for up-gradation of NH -565 from Km 357/240 to 360/145 to two lane with paved shoulders in the State of Andhra Pradesh under NHDP-IV in favour of Executive Engineer- In principle (Stage-I) approval accorded–Demand notice for payment of Net Present Value –issued –Request for conditions compliance –Reg.

In the reference 1<sup>st</sup> cited, the Government of India, MoEF&CC, Chennai have accorded in-principle (Stage-I) approval, under FC Act, 1980 for diversion of 1.737 Ha of forest land in Singanapalli –A RF of Nellore Division for up-gradation of NH -565 from Km 357/240 to 360/145 to two lane with paved shoulders in the State of Andhra Pradesh under NHDP-IV in favour of Executive Engineer, NH division, Kadapa, subject to the conditions stipulated therein.

In the reference 2<sup>nd</sup> cited, the Prl. Chief Conservator of Forests (HoFF), A.P, Hyderabad had communicated the Central government approval in principle (Stage-I) and instructed to raise Demand Notice to the User Agency for payment of Net Present Value (NPV) amount. The Prl., Chief Conservator of Forests further instructed to obtain compliance as per the conditions stipulated in the reference 1<sup>st</sup> cited from the user agency.

For fulfillment of condition Nos.(iii), (v), (vi) and (xiv) the user agency is required to deposit the following amounts.

The user agency should pay the above said amount of Rs.111.743 lakhs through e-payment mode i.e. challan generated through the Ministry's website portal (i.e. www.forestclearance.nic.in). The amount should be deposited either in SB A/c No.SB01025198, Compensatory Afforestation Fund (CAF), Andhra Pradesh, corporation Bank, CGO complex, Lodhi Road, New Delhi-110 003 (RTGS/IFSC No. CORP0000371) or in SB A/c No.344902010105407 - Andhra Pradesh CAMPA, Union Bank of India, Sundar Nagar, New Delhi-110003 (RTGS / IFSC No. UBINO534498).

The user agency is also requested to submit condition wise compliance as stipulated in the reference 1<sup>st</sup> cited. In addition to the above the user agency should comply the following in accordance with the Government of India instructions issued vide F.No.7-23/2012-FC,dt.24.07.2013.

Further, the user agency is requested to submit unconditional undertaking on Rs.100/- judicial stamp paper to pay the revised amount of Net Present Value of the diverted forest area if any becoming due after revision of the same by the Supreme Court of India in future. The User Agency should note that transfer of forest land should be effected only after according of final approval.
