


## Detailed note on the Project.

Bommiyampatti RF is situated in Omalur Taluk of Salem District, Tamil Nadu and the Danishpet Forest Range of Salem Forest Division has controls the Reserved Forest area administration.

In the forest area, there is an very old temple is worshiped by the nearby villagers. Lord Sri Muniyappan idol worshipped here (Lokur Sri Kulikattu Muniyappan Temple). This temple is not mentioned in the Reserved Forest Notification.

In the Bommiyampatti Reserved Forest, Lokur Kulikattu Muniyappan Temple is situated along the road side of Deevattipatti-Bommidi Road. This workplace temple is in existence around 80 years from our forefathers. This temple is situated at an outer extent of one Acre by 87 metres length and 45 metres breadth. Muniyappan statue worshiped in the platform constructed about 40 years ago and covered with Asbestos sheet roof.

Bommiyampatti RF is situated in the outer foot of Shervaroy hill. People living in and around Lokur, Chinna Vadagampatti, Periya Vadagampatti, Kanavaipudur, Danishpettai villages and many hamlets are worshiping the god and lot of people visiting the temple for worship. Numbers of devotees are increasing day by day and tribal people living nearby the forest area are also offering worship to fulfill their religious faith.

Hence to regularize the temple under admitted right, forest area diversion proposal has been submitted.

For the proposed diversion of forest land occupied for temple usage, it is proposed to hand over double the extent of land measuring 2 areas in S.F. No. 431/11 of No. 002 Veppilai Village of Omalur taluk, this area owns in the name of Thiru A. Munusamy, S/o. Late Arumuga Gounder priest of the temple vide the sale deed of the land. A copy of Adangal Register (Village Accounts Revenue record) extract issued by the Village Administrative Officer of Veppilai village, Salem District is enclosed.

We have given undertaking to pay the Net Present Value, Additional NPV of forest land any fixed by the Forest Department, and Compensatory Afforestation cost for raising plantation in the compensatory land to be handed over to the Forest Department.

We request that the proposal may please be considered and approval may kindly be accorded for the diversion of this small portion of 0.3915 Ha of forest land for temple worship purpose to fulfill the religious aspiration of peoples living in the area and worship the lord without any objection from the Forest Department Officials for the usage of forest land for the religious duty.
