In compliance of the Ministry of Environment and Forest (MoEF), Government of India's letter No. 11-9/98-FC (pt.) dated 3 rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non-forest purposes read " with MoEF's letter dated 5 th February 2013 wherein MoEF issued certain relaxation in respect of linear projects, it is certified that 20.5 Hectares of forest land proposed to be diverted in favour of **Executive Engineer, Dibrugarh Water Resource Division, Dibrugarh** (name of user agency) for extension of the **Brahmaputra Dyke Ph-IV** (purpose for diversion of forest land) in **Dibrugarh** district falls within jurisdiction of Chowalkhowa Madala Gaon to Madhupur Deuri Gaon Village(s) in Dibrugarh West Revenue Circle, Dibrugarh tehsils.

- b) Collect all the resolution of the concerned Gram Sabhas.
- c) Consolidate maps and details provided by the Gram Sabhas.
- d) Examine the resolutions and maps of the Gram Sabhas to ascertain the veracity of the claims.
- e) Hear and adjudicate disputes between Gram Sabhas on the nature and extent of any Forest rights.
- f) Hear petitions from persons aggrieved by the resolutions of the Gram Shabhas.
- g) Co-ordinate with other Sub-Divisional Level Committee for inter Sub-Divisional claims.
- h) Prepare block/Circle draft record of forest rights after reconciliation of Government records.
- i) Forward the claims with the draft record of forest rights through the Sub-Divisional officer to the Dist. Level Committee for final decision.
- j) Raise awareness through workshops and other means about the objectives provisions and procedures of the Acts and in Rule 25(4).
- k) Ensure easy and free availability of preformed of claims as provide in Annexure –I to these Rules.
