At the outset, the Dist. Collector Kamareddy has reviewed the proposals submitted by Revenue Divisional Officer Yellareddy for obtaining Forest clearance under RoFR Act Conservation Act, 1980 for the purpose of Diversion for 4.723 Ha, of Forest land for forest Division for the approach road work "Improvements of Banswada – Uppalwai road from Km 17 / 080 to 18 / 278 & 22 / 180 to 23 / 042 in single lane BT Raod to an extent of 4.7231Ha is passing through the limits of Pothangal Kalan (V) and Medipalli (V) Grampanchayath jurisdiction of Gandhari Mandal of Kamareddy District- based on the requisition of the Executive Engineer, R&B, Kamareddy Division.

2. The RDO Yellareddy has informed the committee that, the Sub Divisional Level RoFR Committee meeting of Yellareddy Division has been conducted on 15.11.2019 at 3.00 PM, with MPP, Gandhari (M), ZPTC, Gandhari (M), Dist. Tribal Development Officer, Kamareddy, Sarpanch Medipalli (V), Sarpanch Pothangal Kalan (V), Forest Divisional Officer, Kamareddy, and the committee has unanimously resolved to divert forest land to an extent of 4.7231 Ha, for road work "Improvements of Banswada – Uppalwai road from Km 17 / 080 to 18 / 278 & 22 / 180 to 23 / 042 in single lane BT Raod, passing through the limits of Pothangal Kalan (V) and Medipalli (V) Grampanchayath jurisdiction of Gandhari Mandal of Kamareddy District, and the same are recorded in minutes of meeting.
