Details of pipeline laying Along & Across SH-38, MDR & NH-8A/NH-47 in Limbdi Taluka, SH-17 in Lakhtar Taluka, SH-38 & MDR in Chuda Taluka and SH & SH-119 in Thangadh Taluka which has been declared as Protected Forest are furnished below.

For laying purpose 0.30/0.40 mtr. width is proposed for the pipeline parallel and crossing SH-38, MDR & NH-8A/NH-47 in Limbdi Taluka, SH-17 in Lakhtar Taluka, SH-38 & MDR in Chuda Taluka and SH & SH-119 in Thangadh Taluka are in Surendaranagar District. With this provision of 0.30/0.40 mtr. width and 60834.96 mtr. Length is required for parallel and across various roads. Total 1.8894 Ha. of area is required in Protected Forest for pipeline laying parallel and crossing various roads in Surendranagar District.
