AUTHORISATION LETTER

The project named "KARNATAKA URBAN WATER SUPPLY MODERNISATION PROJECT (KUWSMP)" Diversion of 0.0917 ha. of forest land in FRS No. 93 in Yamnapur & FRS No. 60 in Kanabargi village of Taluka & District Belagavi for KUWSMP 24X7 water supply project to Belagavi city - To lay Clear Water Transmission main (1067mm Diameter) MS pipes from existing Water Treatment Plant at Basavankolla hillock to various service reservoirs in favour of commissioner, City Corporation, Belagavi

This is one of the ambitious projects of Govt. of Karnataka to provide continuous 24x7 pressurised water supply to bring reforms in water supply sector in the state with the financial assistance of World Bank. The project is taken up to cover entire areas of City Corporation of Belagavi. The PROJECT REPORT and its financial model are approved by the Govt. of Karnataka vide GO: UDD 244 PRJ 2013 Dated 07.11.2013.

After detailed study of the topography and hydraulic feasibility for laying of Clear Water Transmission Main of MS 1067mm Dia Pipe from Basavanakolla Water Treatment Plant to Over Head Service Reservoir at Kanabargi and other Over Head Service Reservoir's of Belagavi City at various locations in the city are identified and hydraulic model is finalized. Based on the hydraulic suitability to provide Continuous 24x7 pressurised water supply to Kanabargi area and Belagavi City (North) areas of Over Head Service Reservoir's are to be feed from Basavanakolla Water Treatment Plant the proposed Clear Water Transmission Main Pipe line alignment as per Topography and Hydraulic feasibility the alignment passes through the Reserve Forest. This office has already submitted a proposal in this regard through web portal bearing No. SW/220965/2021 & Unique Proposal No. FP/KA/Water/43438/2019.

In this connection it is to submit that for further approval and scrutiny of forest proposal in your department pertaining to above said works, I am herewith authorizing Shri. Ashok.M.Burukule, Executive Engineer, PIU, KUWSMP-KUIDFC, Belagavi.
