Ministry of Environment, Forests and Climate Change, Government of India conveyed the 'in-principle' approval for diversion of 141.99 Ha. of Protected Forest land & Zudpi Forest land under Forest (Conservation) Act, 1980 for the proposed Ash utilization, promotion and Research park at village Kachewani & Mendipur, Tal. 
