The irrigation Department of Government of Gujarat, Narmada Water Resources Water Supply and Kalpasar Development has planned to erect pumping station at Kukarmunda. To avail electricity for this pumping station, NWRWS&K, Ukai demanded 66KV line connection from GETCO. As per approval of GETCO corporate office vide ref.(1), it has planned to established 66KV tower line from existing 66kv uchchhal Sub-station to proposed kukarmuda pumping station with ACSR Dog conductor, some portions of this line are felt in Reserved forest area under Tapi jurisdiction.

This office has submitted proposal to forest department for the Diversion of **20.8080 Hac. Forest land** proposal for diversion of Forest Land for forest clearance for Erection of 66KV tower line from exist 66kV Uchchhal substation to Proposed Kukarmunda Pumping station. The **procedure for forest approval requires certificate from collector of Tapi regarding Schedule Tribe & other traditional forest dwellers (recognition of forest rights) Act – 2006**
