

I, Medepalli Bhagya Raju S/o Rajendra Prasad, age 50 years, Resident of D.No.26-32-21/1, A.T.Agraharam, Guntur, Executive Engineer/Construction Division/Guntur in respect of diversion of 0.51Ha in compartment No.127, Kondaveedu Reserve Forest at proposed Nagaravanam area in Guntur district do hereby undertake to abide by the terms & conditions incorporated by the Government of Andhra Pradesh in G.O.Rt.No.127, Dt. 22.06.2017 EFS & T Department (Section-II).

- I. I hereby undertake that the legal status of the diverted forest land shall remain unchanged.
- II. I hereby undertake that the demarcation of the forest area proposed for diversion shall be carried out by erecting cement concrete pillars duly numbered at an interval of 20 meters at our cost.
- III. I hereby undertake that the Net Present Value (NPV) of the diverted forest land was already paid as per the orders of Hon'ble Supreme Court, Dt. 28.03.2008 and 09.05.2008 in IA Nos. 826 in 566 with related IA's in Writ Petition (Civil) No. 202 of 1995 and as per the orders issued by Government of Andhra Pradesh vide Go.Ns.No.124 EFS& T (For.I) Department, Dated: 27.07.2010.

- IV. I hereby under take that no tree felling shall be done except trim the branches of trees for maintaining the clearance as per Indian Electricity Act.
- V. I hereby undertake that an amount of **Rs. 56.00 Lakhs** was already deposited towards compensation for the infrastructure existing in the premises of Nallapadu Central nursery and Nagaravanam vide challan generated through Ministry of Environment, Forest and Climate Change on 05.08.2017.
- VI. The amount of Rs. 59.1926 Lakhs was paid on 05.08.2017 towards Net Present Value (NPV) and compensation amount under this project in the condition No.(5) above was deposited in favour of Andhra Pradesh, CAMPA in **A/c.No.15059116258552017841 with IFSC Code: CORP0000633 Corporation Bank** through RTGS.
- VII. I hereby undertake that payment of additional amount of the Net Present Value (NPV) of the diverted land if any becoming due after revision of the same by the Hon'ble Supreme Court of India in future shall be charged by the state government shall be deposited.
- VIII. I hereby undertake that other conditions specified in the Government of India, Ministry of Environment, Forest and Climate Change, letters Dt.13.05.2011, 16.06.2011 and 10.12.2012, shall also be complied with by Principle Conservator of Forests & Head of Forest Force, Andhra Pradesh.
- IX. I hereby undertake that the total forest are utilised for the project shall not exceed 0.51Ha. In case the land is not taken over by us or the same is not used for the stipulated purpose with in a period of two years, then the area shall be taken back by the forest department.
- X. I hereby agree to undertake that the approval shall be valued for a period of five years and it is also agree that in the event of non-compliance of the above conditions, the approval shall automatically stand revoked.
- XI. I here by agreed to under take that existing Bore well that caters the needs of central Nursery and the Children park in Nagaravan shall be retained in the same place. I also agree that the Bore well shall not be obstructed and existing pipe line in any way or any manner.
- XII. I here by agree to under take that the existing electrical transformer erected by the Forest Department to cater the need of water to the nursery, Bore wells and quarters shall be shifted at our own cost, if necessary.
