It is submitted that the Chief Conservator of Forests, Medak vide reference 13<sup>th</sup> cited respectively, have furnished the condition-wise compliance report received from DFO's, Medak and Sangareddy in (3) sets, for according necessary approval U/s 2 of Forest (Conservation) Act, 1980 for diversion of 10.1437 ha (7.9657 Ha in Medak division + 2.178 Ha in Sangareddy division) of Forest land for Erection of of 220 KV Multi Circuit Line and UG cable from 400 KV SS Narsapur to proposed 220/132/33 KV Bowrampet SS in Rangareddy District in favour of Superintending Engineer, OMC/Metro-West/TSTRANSCO, Mint compound, Hyderabad. Demarcation of the proposed forest area shall be carried out by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters by the User Agency in consultation with the DFO concerned at the project cost before the Stage II approval

The Government is requested to forward the condition-wise compliance report to Government of India, Ministry of Environment & Forests and Climate Change, Integrated Regional Office, Hyderabad for according final approval.
