It is submitted that the Government of Andhra Pradesh in the ref.1st cited have accorded Stage-I approval for diversion of 0.52 Ha of forest land for rehabilitation and upgradation of NH-221 (new NH-30) from Km 32.700 to Km 72.200 (Chandragudem to AP/TS Border Section) in the state of AP to two lanes with paved shoulders on EPC Mode - in Krishnaraopalem RF (Compt. No. 80) with certain conditions stipulated therein and requested to furnish the compliance report for according final approval for the project.

Accordingly, the Conservator of Forests, Rajamahendravaram vide reference 3rd cited has submitted the condition wise compliance report on the conditions stipulated by the Government.

The condition wise compliance report is as follows.

(i)	The legal status of the forest land shall remain unchanged.	: There is no change in legal status of diverted forest land.

(iii)	<p>The demarcation of the forest area proposed for diversion shall be carried out by erecting cement concrete pillars duly numbered at an interval of 20 meters at the cost of User Agency.</p>	<p>The user agency has erected cement concrete pillars duly numbered at an interval of 20 meters in the proposed diverted area.</p>
(iii)	<p>The user agency shall pay the Net Present Value (NPV) of the diverted forest land as per the orders of the Hon'ble Supreme Court, dated 28-3-2008 and 9-5-2008 in IA Nos. 826 in 566 with related IA's in Writ Petition (Civil) No. 202 of 1995 and as per the orders issued by Government of Andhra Pradesh vide. Go. Ms. No. 124 EFS&T (For.I) Dept., Dt: 27.07.2010.</p>	<p>The user agency has paid an amount of Rs. 3,95520/- (i.e. Rs. 3,25,520/- towards NPV and 70,000/- towards CA) as per the approved demand notice and challan generated in online through portal dated: 31.08.2016, has been remitted/paid to Ad-hoc CAMPA Fund dt: 07.09.2016. A copy of transaction acknowledgement and the bank receipt in token of having received the funds (By Union Bank of India) through email alert of CL payment furnished by the Divisional Forest Officer, Krishna Division, Vijayawada is enclosed.</p>
(iv)	<p>Additional amount of the Net Present Value (NPV) of the diverted forest land, if any becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be paid by the User agency. The user Agency shall furnish an undertaking to this effect.</p>	<p>The user agency has agreed to comply with this condition. The undertaking furnished by the user agency is enclosed herewith.</p>
(v)	<p>The cost of CA plantation in degraded forest land prepared by the DFO, with a financial outlay of Rs. 0.700 lakhs for a period of 7 years in Krishnaraopalem R.F raised and maintained by the Forest Department.</p>	<p>The user agency has paid an amount of Rs. 70,000/- for this purpose.</p>
(vi)	<p>The funds received from the user Agency towards Net Present Value (NPV), and the cost of CA plantation under this project shall be deposited either in SB A/c No. SB01025198, Compensatory Afforestation Fund (CAF), Andhra Pradesh Corporation bank, CGO Complex, Lodhi Road, New Delhi -110 003 (RTGS/IFSC No. CORP0000371) or in SB A/c No. 344902010105 407-Andhra Pradesh CAMPA, Union Bank of India, Sundar Nagar, New Delhi-110003 (RTGS/IFSC No. UBINO534498).</p>	<p>The user agency has paid an amount of Rs. 3,95520/- (i.e. Rs. 3,25,520/- towards NPV and 70,000/- towards CA) as per the approved demand notice and challan generated in online through portal dated: 31.08.2016, has been remitted/paid to Ad-hoc CAMPA Fund dt: 07.09.2016. A copy of transaction acknowledgement and the bank receipt in token of having received the funds (By Union Bank of India) through email alert of CL payment furnished by the Divisional Forest Officer, Krishna Division, Vijayawada is enclosed.</p>

(vii)	Other conditions specified in the Gol, MoEF & C.C, letter dated:13.02.2014 shall also be complied with by Principal Chief Conservator of Forests, Andhra Pradesh, Hyderabad and user agency with which they are concerned.	: The user agency has agreed to comply with this conditions vide their letter no. File.no: MORTH/PIU/MPT/NHDP-IV/NH-221/Forest, dt.16.09.2016 (copy enclosed)
(viii)	The total forest area utilized for the project shall not exceed 0.52ha. In case the land is not taken over by the user agency or the same is not used for the stipulated purpose within a period of two years, then the area shall be taken back by the Forest Department.	The user agency has agreed to comply with this conditions vide their letter no. File.no: MORTH /PIU /MPT /NHDP-IV /NH-221 / Forest, dt.16.09.2016 (copy enclosed).
(ix)	After receipt of the compliance report of the above conditions, the proposal will be considered for final approval. Transfer of forest land to the user agency shall not be effected prior to the issue of final approval. This approval shall be valid for period of 5 years. In the event of non compliance of the above conditions, this approval shall automatically stand revoked.	: The Divisional Forest Officer , Vijayawada has stated that, the user agency has implemented the condition nos (ii),(iii),(v) and (vi) and agreed to comply with the other conditions.

The condition wise compliance report on the conditions stipulated by the Government in their Stage-I approval has been obtained from the D.F.O., Krishna Division, Vijayawada and Conservator of Forests , Rajamahendravaram is submitted herewith.

The Government are requested to accord final approval of the said project at the earliest.
