Subject: **Diversion of 0.12 hectare of forest land in favour of HPSEB Ltd., for setting up 33/11 KV, 2x1.6 MVA Sub Station at Bhutti (Lug Valley), within the jurisdiction of Kullu Forest Division, Distt. Kullu, H.P.**

Sir,

Please refer to GoHP letter of even number dated 08.06.2017 on the above mentioned subject vide which "in-principle" approval was accorded to the proposal as cited on the subject cited above.

2. Since, the amount of CA has been deposited by the user agency in current account of Ad-hoc CAMPA, after careful consideration of the proposal, approval of the State Govt. is hereby conveyed for diversion of 0.12 hectare of forest land for the above mentioned project, subject to the following conditions:-

1. Legal status of the forest land will remain unchanged.
2. Compensatory Afforestation has been proposed in terms of number of plants. 100 tall plants will be planted in Dughilag-III. Plantation will be done within one year from the date of issued of this letter.
3. Only one tree of Kosh is standing over the forest land proposed for diversion.
4. The forest land will not be used for any purpose other than mentioned in the proposal.
5. No damage of any kind will be caused to the adjoining forest area and all the protection/preventive measures of stability of the area will be strictly adhered to.
6. Muck/Debris generated during the construction, will be properly disposed, and not rolled down along hill slope.
7. The user agency will abide any condition that may be imposed by the State Forest Department in the interest of the protection and development of the forest area.
8. It will be the responsibility of the user agency to obtain approval/clearance under all other relevant Acts/Rules/Court's Rulings/Instructions etc. as applicable to this proposal.

The Govt. may revoke/suspend the clearance if implementation of any of the above conditions is not satisfactory. The concerned DFO/CF & user agency will ensure fulfillment of these conditions.
