No. 19 of Chandel village of Pernem Taluka, North Goa Forest Division & District for CAT-I Approach Lighting System for International Airport at Mopa in Goa in favour of Director, Directorate of Civil Aviation , Government of Goa.

PUC is the letter dated 28/11/16 (pg. 13/c-14/c) from Regional office, MoEF&CC, Bangalore regarding in-principle approval (Stage-I) under section 2(ii) of Forest (Conservation) Act, 1980 for diversion of 0.1133 ha. of forest land in Sy. No. 19 of Chandel village of Pernem Taluka, North Goa Forest Division & District for CAT-I Approach Lighting System for International Airport at Mopa in Goa in favour of Director, Directorate of Civil Aviation Government of Goa, by stipulating certain conditions to be complied by the user agency. The status of the compliance submitted by the user agency and comments of the DCF (North) at pg. 19/c-20/c) is indicated below.
