

With reference to the proposal forwarded by the Forest Department, Government of India, vide letter No. 6-871-2017-18-FD/3376 dated 28th September 2017, Central Government's approval in-principle (Stage I) under section '2' of Forest (Conservation) Act, 1980 for Diversion of 0.9261 ha. of forest land for Development of Freedom Fighters memorial at Patradevi and area surrounding the Memorial- Phase I for a period of 20 years subject to the conditions was conveyed vide letter cited at (1).

The conditions mentioned in the letter cited at (1) are complied with.

The demarcation of the proposed forest area is carried out by erecting cement concrete pillars duly numbered at an interval of 20 meters at the cost of the User Agency, before Stage-II approval. The inspection for the same is pending from your end.

The cost of raising plantation of ten times the number of trees to be felled will be realized from the user agency and amount of Rs. 6,45,000.00 has been deposited through challan generated online on web portal.

The rates of compensatory afforestation, Net Present Value. have been deposited through challan generated online and web portal and deposited in appropriate bank online as compliance of the Stage-I clearance. The details are indicated here below:-

In continuation to the letter cited at (4) complying with the conditions conveyed vide letter cited at (1), the following conditions at Sr.No. 8 to 11 are complied:-

8. The proposed forest land shall not be used for any commercial activities and parking facility – Agreed.
9. The total forest area utilized for the project shall not exceed 0.9261 ha. – Agreed.
10. Any other condition that the Additional Principal Chief Conservator of Forests (Central), Regional Office, Bangalore may impose from time to time for protection, improvement of flora and fauna in the forest area and public convenience, will also be applicable – Agreed.
11. Violation of any of the conditions shall invite penal action, as deemed fit by the Additional Principal Chief Conservator of Forests (Central), Regional Office, Bangalore – Agreed.

In view of above, final approval (Stage-II) may be granted for the above mentioned proposal at an early date.
