## Memorandum:-

This office has given an "In Principle" approval for diversion of 0.2385Ha. of Protected Forest land for Underground laying of Optical Fiber cables lines along the Routes vide this office letter date.20/12/2017refered above at (5)

The Reliance JioInfocomm Limited Ahmedabad has reported that it has deposited an amount of Rs. 7400/- towards the cost of Registration fees,Processing Fee in the challan / bank receipt in the account of 8782-Forest remittance (Deposit Head) received vide letter dated 25.03.2016 of Reliance JioInfocomm Limited.

The undersigned is please to convey the formal approval of the Government under Section-2 of the Forest (Conservation) Act. 1980 subject to following conditions.

- The permission granted only for use of the forest land for the purpose specified in the proposal. The legal status of the forest land shall remain unchanged.
- 2) The forest land shall not be used for any purpose other than that specified in the FCA proposal.
- 3) The user Agency will have to obtain permission from this office for carrying out any maintenance works in future.
- 4) The user Agency will have to make good the forest land after use / maintenance work. No tree shall be cut.
- 5) The User Agency will be liable to make good any loss to Forests / Environment caused due to the use of the said land by the user agency.
- 6) The User Agency will seek permission from the Roads & Buildings Department / Science and Technology Department. Sachivalaya, Gandhinagar.
- 7) The Optical Fiber cable line will be laid underground in a trench depth of 2 mtr. and width of 0.45mtr. in between rows of road side plantation.
- 8) As per instructions of letter of APCCF, Land, Gandhinagar, Letter No.JMN/T-29-C/5584-5653/21-22 DATE:14/12/2021 the old proposal FP/GJ/Others/25974/2017 has already issued FRA certificate of this area. So there is no needed of further FRA certificate of this same area.
- 9) Any other condition which the Nodal Officer (FCA) may stipulate from time to time.
