DEMAND NOTICE

Sub. APFD -F(C) Act, 1980 -Diversion of 0.19 Ha. of forest land Udayagiri Range, Nellore Division for laying underground optical fiber cable along existing right of way for providing 4G communication in favour of M/S JIO Digital Fiber Ltd., Visakhapatnam - Stage I clearance accorded by Govt. of India - Issue of demand notice for raising of 100 number of trees in degraded forest area-Reg.

In the reference 1st cited, the Govt. of India have accorded approval for Diversion of 0.19 Ha. of forest land Udayagiri Range, Nellore Division for laying underground optical fiber cable along existing right of way for providing 4G communication in favour of M/S JIO Digital Fiber Ltd., Visakhapatnam.

The Govt. of India vide reference cited in condition No. (iii) has stipulated that the user agency shall deposit cost towards plantation and maintenance of 100 number of trees in degraded forest area. In view of the the above stipulated condition, the degraded RF area has been identified in Nellore RF (Nagaravanam) and cost towards plantation and maintenance of 100 number of trees in the identified degraded RF and prepared the scheme to a tune of Rs. 0.82 lakhs for depositing by the user agency.

In the ref 2nd cited, the Chief Conservator of Forests, Guntur has approved the Scheme for raising and maintenance of 100 number of trees in degraded RF area to a tune Rs. 0.82 lakhs.

I. (a) Procedure for e- challan generation:

- On issue of this demand notice, the user agency shall log in to (<https://parivesh.nic.in/>) to generate e-challan and make payment against the demand.
- Agency shall fill all the details as per the format provided in the portal and submit to Nodal Officer for verification.
- Once it is verified by Nodal Officer, Agency can generate e-challan from the portal.

I. (b) Procedure for Payment through RTGS:

- For payment through RTGS, the representative of the agency should visit his bank branch (RTGS enabled) of a Bank of his choice along with printed e-challan with an Account Number printed on it.

- v. While tendering the e-challan at the bank, the agency must ensure that the unique account number mentioned in the challan should be correctly mentioned as the account number in which funds to be remitted.
- vi. Upon executing the RTGS by the sender/ remitter bank, the amount collected will be credited to relevant CAMPA state account with the Bank on real time basis.
