I am directed to invite your attention to the reference cited and to state that the User Agency, Assistant Divisional Engineer, NABARD and Rural Roads,

Highways, Madurai Division has uploaded a proposal (FP/TN/Road/42704/2019) for diversion of 1.8798 ha of forest land for road upgradation works in Varusanadu – (via) Thummagundu – Valiparai Road (0/0-9/720) Section passing across Myladumparai Bit 39 Reserved Land (0.2438 ha), Myladumparai Bit 47 Reserved Land (0.2455 ha) and Megamalai Reserved Forest (1.3905 ha) of Kadamalaikundu – Myladumparai Panchayat Union, Andipatti Taluk, Theni District for a period of 99 years under Section 2 (1) of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980.

2. The Deputy Director, Srivilliputhur Megamalai Tiger Reserve, Megamalai Wildlife Division, Theni and Chief & Field Director, Srivilliputhur Megamalai Tiger Reserve, Madurai in the reference second and third cited has recommended the above said proposal. Based on the recommendation made by the Deputy Director, Srivilliputhur Megamalai Tiger Reserve, Megamalai Wildlife Division, Theni and Chief Conservator of Forests & Field Director, Srivilliputhur Megamalai Tiger Reserve, Madurai, the Principal Chief Conservator of Forests (FCA) / Nodal Officer has recommended the above said proposal in the Part-IV, Form-A in Parivesh1.0 portal and the Principal Chief Conservator of Forests (HoFF) has forwarded the same to Government for its consideration and has requested to obtain approval from the Regional office, Government of India.

3. In this regard, the Principal Chief Conservator of Forests (HoFF) has further stated as follows :-

The people from Valiparai, Thummagundu, Varusanadu, Moolakkadai, Ottanai, Murukkodai and Royarkottai villages are mainly using this road to reach nearby major villages and major towns nearby. The adjacent rural communities relying on this road for access to their higher education and hospital facilities. Enhancing this road will significantly improve connectivity for local residents, facilitating easier access to essential services nearby towns and cities. Upgrading the road will improve safety for local communities, particularly during night time travel. This road will be useful to local people to promote economic activities, including agriculture by providing smoother transportation of goods and services. No alternative was considered, as the project is site specific.

4. On further clarification, the Principal Chief Conservator of Forests has stated that the wildlife mitigation measures to be undertaken. The wildlife mitigation measures plan pertinent to the above proposal has been approved by the Principal Chief Conservator of Forests & Chief Wildlife Warden, Chennai vide Ref. No.WL5/1581/2025, dated 02.07.2025. The user agency has also submitted a wildlife clearance application in Parivesh 2.0 for the above subject proposal. Now, EDS has been raised by the Principal Chief Conservator of Forests & Chief Wildlife Warden on 08.09.2025, and the reply to the EDS raised in the wildlife clearance is under preparation. Hence, the Principal Chief Conservator of Forests has requested that this proposal may be considered.

5. The Government have examined the proposal in detail (copy enclosed) and decided to recommend the proposal for diversion of 1.8798 ha of forest land for road upgradation works in Varusanadu – (via) Thummagundu – Valiparai Road (0/0-9/720) Section passing across Myladumparai Bit 39 Reserved Land (0.2438 ha), Myladumparai Bit 47 Reserved Land (0.2455 ha) and Megamalai Reserved Forest (1.3905 ha) of Kadamalaikundu – Myladumparai Panchayat Union, Andipatti Taluk, Theni District in favour of Assistant Divisional Engineer, NABARD and Rural Roads, Highways, Madurai Division for a period of 30 years under section 2(1) of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and forward it to Regional office,

Government of India, Ministry of Environment, Forests and Climate Change, Chennai for obtaining their concurrence, subject to the following conditions:-

- i) The legal status of the diverted forest land shall remain as unchanged.
- ii) Demarcation of the proposed forest area shall be carried out by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at the cost of the User Agency.
- iii) The Compensatory Afforestation (CA) shall be carried out in the Non-Forest Land identified in Theni District at the cost of User Agency.
- iv) The User Agency has to transfer and mutate the 1.8798 ha of non-forest area of compensatory land identified in Bodi North Hills village in Theni Forest Division in favour of Forest Department.
- v) The Non-Forest land identified in Theni District for Compensatory Afforestation and the approved Compensatory Afforestation scheme shall not be changed without prior approval of the Central Government and the amount realized from the User Agency towards Compensatory Afforestation should not be left unspent.
- vi) The Net Present Value of 5 times shall be charged for the diverted forest land inside the Wildlife Sanctuary (Megamalai Reserved Forest – 1.3905 ha) and one time shall be charged for the diverted forest land inside the Reserved Lands (Myladumparai Bit 39 Reserved Land – 0.2438 ha and Myladumparai Bit 47 Reserved Land – 0.2455 ha) in Megamalai Wildlife Division from the User Agency as per the orders of the Hon'ble Supreme Court dated 28.03.2008 and 09.05.2008 in IA Nos. 826 in 566 with related IA's in Writ Petition (Civil) No. 202/1995 and Ministry's guideline No.5-3/2011-FCIVol-I) dated 06.01.2022 and clarification issued vide letter dated 19.01.2022 and 22.03.2022.
- vii) Additional amount of the Net Present Value (NPV) of the diverted forest and if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged from the user Agency. The User Agency shall furnish an undertaking to this effect.
- viii) All the funds received from the User Agency under the project shall be transferred / deposited to CAMPA fund only through e-portal (<https://parivesh.nic.in/>.)
- ix) The forest land proposed for diversion shall under no circumstances be transferred / sublet to any other agency, department or person without prior approval of the Central Government.
- x) The layout plan of the proposal shall not be changed without the prior approval of the Central Government.
- xi) No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- xii) The User Agency shall provide fire wood preferably alternate fuel to labourers working at the site to avoid damage / tree felling.
- xiii) Disturbance shall be kept minimal by creating labour camps outside the forest area as far as possible and it will be the responsibility of the User Agency to ensure that the labourers & staff engaged in execution of work do not destruct nearby forest flora & fauna.
- xiv) The total forest area utilized for the project shall not exceed 1.8798 ha and the forest area diverted shall not be used for any purpose other than those shown in the diversion proposal.

- xv) The forest area proposed for diversion is falls inside the Wildlife Sanctuary. Hence, the User Agency shall obtain necessary permission / recommendation from the Standing Committee for National Board of Wildlife. In case of rejection of proposal under Wildlife Protection Act, 1972, then the Stage I approval accorded under Van (Sanrakshan E�am Samvardhan) Adhiniyam, 1980 will stand cancelled automatically. The State Government shall realize all levies only after obtaining of permission from Standing Committee of the National Board for Wildlife.
- xvi) The User Agency shall ensure compliance to provisions of the all Acts, Rules, Regulations and Guidelines, for the time being in force, as applicable to this project.
- xvii) Any other conditions that the Central Government or Deputy Director General (Central) of Regional Office, Chennai may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the User Agency.
- xviii) In the event of failure to comply with any of the above conditions the User Agency is liable for penal action as per the rules / guidelines issued under Van (Sanrakshan E�am Samvardhan) Adhiniyam, 1980.
- xix) The User Agency has to pay the cost towards annual lease rent for the forest area diversion period as fixed by the Forest Department at the time of sanction along with any escalation in future for the entire project period.
- xx) Period of lease is thirty (30) years. The User Agency has to apply renewal proposal before one year of expiry of lease with the State Forest Department.

6. I am, therefore, directed to request you to kindly obtain the In-principle approval of the Competent Authority and communicate the same to this Government, early.

I wish to state that in the reference 1st cited, the Assistant Divisional Engineer, NABARD and Rural Roads, Highways, Madurai Division has furnished online application under Section 2 of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for the above proposal under the Proposal No. FP/TN/Road/42704/2019.

1) Brief details of the project are given below:

i. The User Agency has uploaded the proposal in the prescribed format, Form-A: Part-I under Section 2 of Van (Sanrakshan Evam Samvardhan)

Adhiniyam, 1980 for diversion of fresh forest area in Parivesh 1.0 module.

- ii. Name of the project reported as, Road upgradation works in Varusānadu - (via) Thummagundu - Valiparai Road (0/0 - 9/720) Section in Kadamalaikundu - Myladumparai Panchayat Union, Andipatti Taluk in Theni District.
- iii. Project proposal number reported as, FP/TN/Road/42704/2019.
- iv. Short narrative of project reported as, The proposed road upgradation works in Varusānadu - (via) Thummakundu - Valiparai Road (0/0 - 9/720) Section. The road passing across Mandakaradu, Kalarimalai, Silamuttu Medu of Megamalai R.F. in Megamalai Wildlife Division, Theni in Kadamalaikundu - Myladumparai Panchayat Union, Andipatti Taluk in Theni District.
- v. Category of the Proposal reported as, Road.
- vi. Shape of forest land proposed to be diverted reported as, Linear.
- vii. Area of forest land proposed for diversion of forest land for road upgradation works is 1.8798 ha, as per the field verification of the Deputy Director, SMTR, Megamalai Wildlife Division, Theni. Most of the details previously uploaded could not be corrected at present in PARIVESH Portal, due to portal issues. Hence, recommended area related details may be considered as final.
- viii. Non-forest land required for this project reported as, 'Zero' ha.
- ix. Total period for which forest land is proposed to be diverted reported as, 99 years.
- x. Details of User Agency reported as, NABARD and Rural Roads, Highways Department, Madurai Division. Legal status of User Agency reported as, State Government.
- xi. Details of Person Making Application reported as, Thangapandi, Assistant Divisional Engineer, NABARD and Rural Roads, Highways Department, Madurai Division. Copy of documents in support of the competence / authority of the person making this application to make application on behalf of the User Agency uploaded.

- xiii. Copy of Survey of India Toposheet indicating boundary of forest land proposed to be diverted is enclosed.

2) **In the Part II** of Form-A uploaded in the web portal, the Deputy Director, SMTR, Megamalai Wildlife Division, Theni has reported the following details.

i) Forest area diversion of 1.8798 ha of forest land in Myladumparai Bit 39 RL (0.2438 ha), Myladumparai Bit 47 RL (0.2455 ha) and Megamalai RF (1.3905 ha) in Megamalai WL Division has been proposed for diversion. Eco-class of forest area reported as Eco-Class 3 with density of forest area reported as '0.4'. Species wise and girth class wise enumeration of tree details reported as 'zero'.

ii) On Brief vulnerability of forest area to erosion reported as "The existing ghat cutting on the road side in Myladumparai Bit 39 RL and the first 428 m of road in Megamalai RF is minimally susceptible to erosion".

iii) Approximate distance of the proposed site for diversion from boundary of forest reported as 'zero'.

iv) Significance of the forest land proposed for diversion reported from Wildlife point of view reported as follows:

- a. Details of wildlife present in and around the forest land proposed for diversion reported as Indian Gaur, Sambar, Spotted Deer, Grizzled Giant

b. Whether forms part of national park, wildlife sanctuary, biosphere reserve, tiger reserve, elephant corridor, wildlife migration corridor etc., reported as 'Yes'. Details and comments on the impact of Project on such areas reported as, the road falls in Megamalai RF, Myladumparai Bit 39 RL and Myladumparai Bit 47 RL which are part of the Srivilliputhur Megamalai Tiger Reserve. It is an existing road. The road passing through the RLs are not finding mention in the records. The road connects Thummagundu village with Varusanadu. The road and the village are mentioned in the Megamalai Reserved Forest Notification.

C. Whether the forest land proposed for diversion is located within eco-sensitive zone (ESZ) of the Protected Area notified under Wildlife (Protection) Act, 1972 reported as, 'No'.

d. Whether any national park, wildlife sanctuary, biosphere reserve, tiger reserve, elephant corridor, wildlife migration corridor etc., is located within 1 Km. from boundary of the forest land proposed for diversion reported as, 'No'.

e. Whether any rare/endangered/unique species of flora and fauna found in the area reported as, 'Yes'.

v) There is no protected archaeological / heritage site / defence establishment or any other important monument is located in the area.

vi) Requirement of forest land as proposed by the User Agency is unavoidable and bare minimum for the project.

vii) Whether any work in violation of the Act or guidelines issued under the Act has been carried out reported as, 'No'.

viii) For the diversion of 1.8798 ha of forest land, Compensatory Afforestation has been proposed as 'Yes'. Non-forest land in 3 segments has been identified for Compensatory Afforestation in Theni District. KML file and Google map of the identified land and suitability certificate has been uploaded. The Compensatory Afforestation Scheme for planting 3760 seedlings in 3.798 ha (effective area is 3.76 ha) at a cost of Rs.57,88,240/- including 10-years maintenance is proposed by the District Forest Officer, Theni (jurisdiction of non-forest land identified is located in Theni Forest Division).

ix) The Deputy Director, SMTR, Megamalai Wildlife Division, Theni has uploaded site inspection report for the proposed forest diversion area with the justification as follows:

The proposed road was inspected by the Deputy Director on

06.01.2023, 20.02.2023, 24.02.2023, 16.10.2023 and 07.12.2023. This is the existing bitumen road in the forest and non-forest land. The said road passed through Myladumparai Bit 39 RL (487.6 m), Myladumparai Bit 47 RL (491.0 m) and Megamalai RF (2781.0 m) of Megamalai Wildlife Division, to a width of 5.0 m (bitumen width - 4.0 m and each side berm width - 0.5 m). Myladumparai Bit 39 RL and Myladumparai Bit 47 RL are declared as buffer zone of Srivilliputhur Megamalai Tiger Reserve. Megamalai RF is declared as Srivilliputhur Megamalai Tiger Reserve. Hence, the above road is fall in buffer and core zone of Tiger Reserve respectively. No tree felling is involved. The User Agency has not proposed any culverts or bridges or retaining walls or any other work except road upgradation as bitumen road. The existing ghat cutting on the road side in Myladumparai Bit 39 RL and the first 428.0 m of the road in Megamalai RF is minimally susceptible to erosion. The road is to be considered for the welfare of the bona-fide inhabitants only. Hence, the proposal for upgradation to an identified length of 3759.6 m and width of 5.0 m with a total extent of 1.8798 ha in forest area may be considered in this proposal.

x) In the Part-II of Form-A, the Deputy Director, SMTR, Megamalai Wildlife Division, Theni has recommended the forest area diversion of 1.8798 ha.

xi) In the Part-III of Form-A, the Chief Conservator of Forests & Field Director, SMTR, Madurai has recommended the forest area diversion of 1.8798 ha.

3) As per the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and the provisions of the said Adhiniyam, the authority to process the above subject proposal is the Government of India, Ministry of Environment, Forest and Climate Change, Regional Office, Chennai. The proposal forwarded by the Deputy Director, SMTR, Megamalai Wildlife Division, Theni and the Chief Conservator of Forests & Field Director, SMTR, Madurai is sent herewith duly recommended by the Principal Chief Conservator of Forests (Forest Conservation Act) / Nodal Officer of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for the State of Tamil Nadu subject to the following conditions:

- i. The legal status of the diverted forest land remains unchanged.
- ii. The demarcation of the proposed forest area shall be carried out by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at the cost of the User Agency.
- iii. The Compensatory Afforestation (CA) shall be carryout in the Degraded Forest Land identified in Nagapattinam District at the cost of User Agency.
- iv. The Non-Forest Land identified in Theni District for CA and the approved

CA scheme shall not be changed without prior approval of the Central Government and the amount realized from the User Agency towards CA should not be left unspent.

v. The Net Present Value of 5 times shall be charged for the diverted forest land inside the Wildlife Sanctuary (Megamalai RF - 1.3905 ha) and one time shall be charged for the diverted forest land inside the Reserved Lands (Myladumparai Bit 39 RL - 0.2438 ha and Myladumparai Bit 47 RL - 0.2455 ha) in Megamalai WL Division from the User Agency as per the orders of the Hon'ble Supreme Court dated 28.03.2008 and 09.05.2008 in IA Nos.826 in 566 with related IA's in Writ Petition (Civil) No.202/1995 and Ministry's guideline No. 5-3/2011-FC(Vol-I) dated 06.01.2022 and clarification issued vide letter dated 19.01.2022 and 22.03.2022.

vi. Additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged from the User Agency. The User Agency shall furnish an undertaking to this effect.

vii. All the funds received from the User Agency under the project shall be transferred / deposited to CAMPA fund only through e-portal (<https://parivesh.nic.in/>).

viii. The forest land proposed for diversion shall under no circumstances be transferred / sublet to any other agency, department or person without prior approval of the Central Government.

ix. The layout plan of the proposal shall not be changed without the prior approval of the Central Government.

x. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.

xi. The User Agency shall provide fire wood preferably alternate fuel to labourers working at the site to avoid damage / tree felling.

xii. Disturbance shall be kept minimal by creating labour camps outside the forest area as far as possible and it will be the responsibility of the User Agency to ensure that the labourers & staff engaged in execution of work do not destruct nearby forest flora & fauna.

xiii. The total forest area in forest area utilized for the project shall not exceed 1.8798 ha and the forest area diverted shall not be used for any purpose other than those shown in the diversion proposal.

xiv. The forest area proposed for diversion is falls inside the Wildlife Sanctuary. Hence, the User Agency shall obtain necessary permission / recommendation from the SC NBWL. In case of rejection of proposal under Wildlife Protection Act 1972, then the Stage I approval accorded

under FCA, 1980 will stand cancelled automatically. The State Government shall realize all levies only after obtaining of permission from SC NBWL.

- XV. The User Agency shall ensure compliance to provisions of the all Acts, Rules, Regulations and Guidelines, for the time being in force, as applicable to this project.
- XVI. Any other conditions that the Central Government or DDG (Central) of Regional Office, Chennai may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the User Agency.
- XVII. In the event of failure to comply with any of the above conditions the User Agency is liable for penal action as per the rules / guidelines issued under Van (Sanrakshan Evar Samvardhan) Adhiniyam, 1980.
- XVIII. The User Agency has to pay the cost towards annual lease rent for the forest area diversion period as fixed by the Forest Department at the time of sanction along with any escalation for the forest land to be diverted for the above project in future for the entire project period.
- XIX. Period of lease can be thirty (30) years. The User Agency has to apply renewal proposal before one year of expiry of lease with the State Forest Department.

4) Hence, I request that the above proposal may be recommended and forwarded to ~~Government of India~~, Ministry of Environment, Forest and Climate Change, Regional Office, Chennai for getting In-Principle (Stage-I) approval for diversion of 1.8798 ha of forest land for road upgradation works in Varusanadu - (via) Thummagundu - Valiparai Road (0/0-9/720) Section passing across Myladumparai Bit 39 RL (0.2438 ha), Myladumparai Bit 47 RL (0.2455 ha) and Megamalai RF (1.3905 ha) of Kadamalaikundu - Myladumparai Panchayat Union, Andipatti Taluk, Theni District in favour of Assistant Divisional Engineer, NABARD and Rural Roads, Highways, Madurai Division for a period of 30 years.
