



Sub: - Proposals for clearance under Forest (Conservation) Act, 1980 for "Diversion of 0.2884 ha. of forest land for design & construction of bridge connecting Keri to Tiracol over river Tiracol including approaches in Tiracol Village of Pernem Taluka in favour of Goa State Infrastructure Development Corporation Limited.

PUC is the letter dated 30/12/2015 (at pg. 9/C) from Regional office, MoEF&CC, Bangalore regarding in-principle approval (Stage-I) under section 2(ii) of Forest (Conservation) Act, 1980 for diversion of 0.2884 ha. of forest land for design & construction of bridge connecting Keri to Tiracol over river Tiracol including approaches in Tiracol Village of Pernem Taluka in favour of Goa State Infrastructure Development Corporation Limited, Panaji, Goa by stipulating certain conditions to be complied by the user agency. The status of the compliance submitted by the user agency (at pg. 18/C-20/C & 28/C-29/C) and comments of the DCF (North) at pg. 30/C-32/C is indicated below.

2	The demarcation of the proposed forest shall be carried out by erecting 4 ft high cement concrete pillars duly numbered at an interval of 20 meters at the cost of the user agency before issue of stage II clearance.	As directed area is demarcated with pillars in case of point No. 1, it was coming on the road edge, only a nail was fixed and painted for identification. Stone was not fixed as it would have cause hindrance to vehicles, since the road is narrow. However, 4 feet stone is fixed as instructed (Refer page 1 of Annexure-I) In case of point No. 2, a nail was fixed and painted for identification. Stone cannot be fixed as there is objection from the owner of house / restaurant, since the stone would block his entry/exit. The same nail is therefore maintained and re-painted for easy identification (Refer page 1 of Annexure-I)	The proposed forest area has been demarcated by user agency by 4 feet tall pillars are placed at point No. 1,3,4,5,6,7,9,11 and 13. Further, no pillars placed at point No. 2,8,10,,12,14,15,16,17 and 18 for reason stated by user agency at Col.3


		<p>In case of point No. 3-7 all the old stones are removed and replaced with 4 feet high stones (Refer Annexure-I)</p> <p>In case of point No. 8-18, 4 feet high stones for point no. 1, 3, 4, 5, 6, 7, 9, 11 and 13 are fixed as shown in (Annexure-I). Rest of point's i. e. 8,10,12,14,15,16,17 & 18 are located in deep valley with dense vegetation and hence it is difficult to access and fix stones, photographs indication the same are enclosed at Annexure-II. This was shown to forest official and also informed vide our letter dated 09th March 2020 cited at reference (4) above. Therefore the said points are interpolated on the plan, which is already submitted to your office.</p>




