

This is to inform you that after careful consideration of the Proposal the Government of India, Ministry of Environment of Forests and Climate Change have been pleased to accord in Principle/Stage-I approval under the Forest (Conservation) Act, 1980 for Diversion of 5.117 ha. of forest land for construction of Koraput-Singapur Road Doubling Railway Project from (Km.0.000 to Km.74.800) under Koraput Forest Division by East Coast Railway, Visakhapatnam(AP) in Odisha- Govt. of India subject to fulfillment of the conditions. As per the conditions mentioned at A(i) of the above order, you are requested to deposit the Net Present Value (NPV) as per revised rate @ Rs.9,57,780/- per ha. i.e for (5.117 Ha. X 9,57,780/- = Rs.49,00,960/- (Rupees Forty Nine Lakhs, Nine Hundred Sixty) only in Ad-hoc CAMPA Account through web portal of MoEF & CC under intimation to this office.

Further, you are requested to submit the compliance to the conditions imposed by GoI, MoEF & CC, FC Division, New Delhi in their Final approval order letter issued vide No. 5.ORB 617/2023-BHU dtd.25.01.2024 to this office immediately for further action at this end.


