कृपया संदर्भित ज्ञापन क्र—2 का अवलोकन करें, जिसमें अपर प्रधान मुख्य वन संरक्षक (भू—प्रबंध) द्वारा विषयांकित प्रकरण में सैद्धांतिक स्वीकृति जारी करने की अनुशंसा की गई है।

विषयांकित प्रकरण को भारत सरकार पर्यावरण एवं वन मंत्रालय के पत्र क.एफ.नं. 11—09/1998—एफ.सी. दिनांक 13.02.2014 में निहित सामान्य अनुमोदन के अधिकार के तहत् विचारोंपरांत राज्य शासन एतद् द्वारा बस्तर जिले के बस्तर वनमंडल, के अंतर्गत चोकावाड़ा ग्राम में संरक्षित वन कक्ष क्र. 1809 पी का 0.672 है.वनभूमि में गृह निर्माण मण्डल के अटल विहार कॉलोनी तक पहुंच मार्ग निर्माण के गैर वानिकी कार्य हेतु कार्यपालन अभियंता छत्तीसगढ़ गृह निर्माण मण्डल, संभाग जगदलपुर को वन भूमि उपयोग पर देने हेतु निम्नलिखित शर्तों के अधीन सैद्धांतिक स्वीकृति दी जाती है :--

- (i) Legal Status of the diverted forest land shall remain unchanged;
- (ii) The Nodal Officer shall charge the Net Present Value of the forest area diverted under this proposal from the User Agency as per the Judgement of the Hon'ble Supreme Court of India dated 28.03.2008 & 09.05.2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by this Ministry vide letter No.5-3 /2007-FC dated 05.02.2009 in this regard.
- (iii) The User Agency shall furnish an undertaking to pay the additional NPV, if so determined, as per the final decision of Hon'ble Supreme Court of India.
- (iv) All the funds received from the User Agency under the project shall be transferred to Ad-hoc Compensatory Afforestation Fund (CAF) Chhattisgarh SB01025203 in account number CA 25203 of Corporation Bank, Block-11, CGO Complex, Phase-1, Lodhi Road, New Delhi-110003.
- (v) The Nodal Officer will suggest comprehensive soil conservation measures to be undertaken at the cost of User Agency.
- (vi) Overburden shall not be dumped outside the width of the road. The muck generated in the earth cuttings will be disposed off at the designated dumping sites and in no case the muck/debris will be allowed to roll down the hill slopes. The muck disposal plan, prepared in consultation with the State Forest Department will be submitted along with the compliance report.
- (vii) The user agency shall not fell trees.
- (viii) The User agency shall enumerate the number of trees protected by above restriction and indicate before the stage-II clearance.
 - (ix) No labour camps shall be set up inside the forest area.
 - (x) Additional Diversion of forest land for extension/strengthening of this road shall not be permitted within next five years.
- (xi) The User Agency shall provide fuel wood preferably alternate fuel to the labourers working at the site to avoid damage / felling of trees or the user agency to buy the fuel wood from the extracted timber from the State Department to be used by labourers.
- (xii) No damage to the flora and fauna of the area shall be caused.
- (xiii) The forest land shall not be used for any purpose other than that specified in the proposal.
- (xiv) The user agency will not collect any toll tax from the Forest Department vehicles.
- (xv) User Agency shall make adequate design provisions to facilitate free movement of wildlife across the road, in consultation with the State Forest Department.



- (xvi) The designing of culvert/bridges, if any, over the natural streams/rivers/canals should be done in such a manner that it does not hamper the natural course of water, does not give rise to waterlogging, and also does not hamper movement of wild animals.
- (xvii) The user agency shall take adequate steps for prevention of water logging, sheet erosion etc. in consultation with the State Forest Department.
- (xviii) The user agency shall submit design of road widening with provisions of at least 2-3 rows of long rotation indigenous trees, as per provision of IRC-SP-21-2009 (Guidelines on landscaping & tree plantation), on either side of the road before final clearance.
- (xix) Wherever possible and technically feasible, the User Agency shall undertake afforestation measures along the roads within the area diverted under this approval, in consultation with the State Forest Department at the project cost.
- (xx) To avoid accidental deaths of the wild animals under speeding vehicles, the project authority shall provide speed limit signage at regular intervals. The speed limit shall be 40 km/hr. Besides, ramblers shall be provided at every one km interval.
- (xxi) Any other condition that the State Govt. or the Chief Conservator of Forest (Central), Regional Office, Bhopal, may impose from time to time in the interest of conservation protection and development of flora and fauna of the area.
- (xxii) Presuming the demand of forest land same, during the course of construction, some section of road may need minor deviation from proposed alignment and top width reduction also, to avoid land slide, Under such circumstances the user agency will abide by the inspections of Divisional Forest Officer and other senior forest officials.
- (xxiii) The user agency will meet the cost of expenditure to be incurred on planting on both sides of the road for slope stabilization and also for avenue purposes as demanded by forest department.
- (xxiv) No blasting of rocks will be done and such works will be carried out manually to minimize impact on the fauna found in the area.
- (xxv) If as per Environment Impact Assessment Notification 2006 any approval is needed the User Agency would get it from Ministry of Environment Forest and Climate Change New Delhi.
- (xxvi) Before handing over the forest land the User Agency shall abide by all the latest Rules, Regulations and Guidelines including Scheduled Tribes and Other Traditional Forest Dwellers(Recognition of Forest Rights) Act 2006
- (xxvii) Any change in land use of Forest Land without the permission of Government of India would be treated as violation of Forest Conservation Act 1980. In case change of land use is necessary, The Nodal Officer would request Ministry of Environment Forest and Climate Change Nagpur for that.
- (xxviii) Only after receiving the compliance report, on all the conditions from the Nodal Officer. Final Approval of this proposal would be sanctioned under section-2 of Forest Conservation Act 1980.
