विषय :- Diversion of 1.4445 ha. of forest land in favour of Public Works Department. Shahpura, Jaipur, Construction of Road widening & Strengthening of Manoharpur to Itwa Bhopji Via Nawalpura Charanwas (MDR-187) Proposal No. FP/RJ/ROAD/35096/2018.

सन्दर्भ:- भारत सरकार पर्यावरण, वन एवं जलवायु परिवर्तन मंत्रालय क्षेत्रीय कार्यालय, गांधीनगर (उप क्षेत्रीय कार्यालय जयपुर) के द्वारा Online Proposal No.- FP/RJ/ROAD/35096/2018 में दिनांक 28.08.2023 के द्वारा जारी सैद्धान्तिक स्वीकृति (संलग्न) के क्रम में।

महोदय,

उपरोक्त विषयान्तर्गत प्रस्ताव " Diversion of 1.4445 ha. of forest land in favour of Public Works Department. Shahpura, Jaipur, Construction of Road widening & Strengthening of Manoharpur to Itwa Bhopji Via Nawalpura Charanwas (MDR-187) Proposal No. FP/RJ/ROAD/35096/2018" में 1.4445 हैक्टर वन भूमि प्रत्यावर्तन की स्वीकृति चाही गयी थी। जिसके क्रम में भारत सरकार पर्यावरण, वन एवं जलवायु परिवर्तन मंत्रालय क्षेत्रीय कार्यालय, गांधीनगर (उप क्षेत्रीय कार्यालय जयपुर) के द्वारा Online Proposal No.- FP/RJ/ROAD/35096/2018 में दिनांक 28.08.2023 के द्वारा जारी सैद्धान्तिक स्वीकृति निम्नलिखित शर्तों के साथ प्रदान की गई है:-

A: Conditions which needs to be complied prior to handing over of forest land by the State Forest Department:	
S.No.	Conditions
1.	The cost of compensatory afforestation at the prevailing wage rate as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
2.	The State Government shall charge the Net Present Value (NPV) for the <b>1.4445 ha.</b> forest area to be diverted under this proposal, from the User Agency as per the orders of the Hon'able Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 and <b>revision of NPV vide Ministry letter No. 5-3/2011-FC(Vol-I) dated 06.01.2022</b> in this regard.
3.	The non-forest land proposed for CA shall be transferred and mutated in the name of Forest Department and notified as RF/PF prior to Final/Stage-II approval. A copy of the original notification declaring the non-forest land under Section 4 or Section 29 of the Indian Forest Act, 1927, or under the relevant section of the State Forest Act as the case may be, will be submitted by the State Government prior to Stage-II approval.
4.	Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
5.	The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.

6.	The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the direction of concerned Divisional Forest Officer.
7.	The KML file of the area to be diverted and the CA areas shall be uploaded on the e-Green watch portal with all requisite details, before issuing working permission towards linear projects or submitting compliance report for seeking Final/Stage-II approval, as the case may be.
8.	All the funds received from the user agency under the project shall be transferred/deposited to CAMPA fund only through e-portal.

**B: Conditions which needs to be strictly complied on field after handing over of forest land to the User Agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Final/Stage-II approval:**

1.	Legal status of the forest land shall remain unchanged.
2.	Forest land will be handed over to the User Agency only after required non-forest land for the project is handed over to the User Agency.
3.	Compensatory afforestation shall be taken up by the Forest Department over 1.4445 ha non forest land. Khasra no. 3873/1145, Village-Bishangarh, Tehsil Shahpura, District Jaipur of Rajasthan at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and mono-culture of any species may be avoided.
4.	User agency shall restrict the felling of trees to 68 trees/minimum numbers in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
5.	The User Agency shall raise strip plantation on both sides and central verge of the road as per the IRC Norms.
6.	Speed regulating signage will be erected along the road at regular intervals in the Protected Areas/Forest Areas.
7.	No damage to the flora and fauna of the adjoining area shall be caused.
8.	User agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
9.	The layout plan of the proposal shall be not be changed without prior approval of Central Government.
10.	No labour camp shall be established on the forest land.
11.	Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
12.	The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
13.	No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
14.	The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
15.	The forest land shall not be used for any purpose other than that specified in the project proposal.
16.	The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
17.	The User Agency shall submit the annual self compliance report in respect of the above stated conditions to the State Government and Integrated Regional Office, Jaipur by the end of March every year.
18.	The User Agency shall comply with all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any for the time being in force, as applicable to the project.
19.	Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF & CC Guideline F. No. 11-42/2017-FC dt 29/01/2018.
20.	Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
21.	The compliance report shall be uploaded on e-portal ( <a href="https://parivesh.nic.in/">https://parivesh.nic.in/</a> )

After receipt of compliance report on fulfillment of all of the above conditions from the State Government, proposal will be considered for final approval under Section-2 of the Forest (Conservation) Act,

1980 The User Agency shall take up the work as per the guidelines in force and after ensuring that all necessary clearances for the entire stretch are in place. Working permission, if any issued, shall be intimated us Sub Regional Office, Jaipur Transfer of forest land shall not be effected till final approval is granted by the Central Government in this regard.

Further, it may also be noted that this In-principle/Stage-I approval shall be valid for a period of 5 years from the date of issue of this letter. In the event of non-compliance of the above conditions, this In-principle approval shall be revoked after five (05) years.

अतः उक्तानुसार दी गयी शर्तों की पूर्ति करते हुये निम्नलिखित तालिका में दर्शायी गयी एन.पी.वी. की राशि, क्षतिपूर्ति वृक्षारोपण (CA DFL) एवं 10 वर्षों तक रखरखाव की राशि व रोड साईड वृक्षारोपण एवं वन्यजीवों के संरक्षण हेतु राशि क्रमशः  $(13,83,513.00 + 13,45,000.00 + 49,20,000) = 76,48,513.00/-$  अक्षरे छियत्तर लाख अडतालीस हजार पांच सो तेरह रुपये मात्र "प्रतिपूर्ति पौधारोपण निधि प्रबंधन तथा योजना प्राधिकरण" के तदर्थ निकाय के वेबपोर्टल OSMFWP द्वारा सृजित ई-चालन द्वारा जमा कराने के उपरान्त ई-चालान की छाया प्रति जमा की गई धन राशि का बैंक चालान/यूटीआर संख्या/एनईएफटी नम्बर की छाया प्रति सहित सैद्धान्तिक स्वीकृति की अनुपालना आख्या (जिरामे जमा की गई राशि का मदवार विवरण हो) प्रेषित की जाये। ताकि आवश्यक एवं अग्रिम कार्यवाही की जा सके।
