With reference to the above subject, the user agency is request to pay the NPV of Rs.1,17,676/- and submit the compliance report in the web portal vide 7th reference cited. Now, the Principal Chief Conservator of Forest is request to revised the NPV amount vide 6th reference cited based on the clarification given by GOI, MoEFCC (Forest Conservation Division), New Delhi vide File.No.5-3/2011-FC (Vol-I) Dated: 21.03.2022. As per the instruction given by the Principal Chief Conservator of Forests, Chennai the revised NPV amount for the proposal for diversion of forest land of 0.1756 Ha for providing water supply to 274 rural habitations in over exploited

blocks of Thanthoni union in Karur District in favour of Executive Engineer, TWAD Board, RWS Division, Karur is calculated as follows:

$$\begin{aligned}\text{Open Forest-Eco class-IV-1Ha} &= \text{Rs.4,38,000/-} \\ \text{Proposed land area} &= 0.1756 \text{ Ha.} \\ \text{NPV for proposed land area} &= 0.1756 \times 4,38,000 \\ &= \text{Rs.76,912.80} \\ &(\text{or}) \\ &= \text{Rs.76,913/-}\end{aligned}$$

Hence, the user agency is requested to pay above said revised NPV. And also the user agency is requested to submit the compliance report in the web portal as already said in the 7th reference cited.
