As per the reference cited above vide letter Number 1 the Govt. of India has issued the Stage-I for the renewal of forest clearance of 80.77 ha. forest land in favour of Durgapur Open Cast Project. The user agency has already deposited NPV amount of Rs. 6,26,77,520/- @ Rs. 7.76 Lac per hectore during the initial diversion. User agency needs to deposit the difference of NPV amount to the CAMPA for this renewal proposal. Hence, it is directed to the agency for fulfillment of condition/s to pay the item-wise amount for the year 2025-26 of compensatory levies as per the following details.
