Sub:- Diversion of 1.81 ha forest land in addition to the earlier diversion over 23.581 ha of forest land within the Mining Lease area of 28.397 ha in respect of Patabeda Iron Ore Mines of M/s MGM Minerals - Submission of Stage-I Compliance regarding.

Ref-: GoI, MoEF & CC, ERO, BBSR Letter F. No. 8(21)28/2003-FCE dated 04.03.2020.

Sir,

In inviting reference to the above mentioned subject, this is to inform that Government of India, Ministry of Environment, Forest & Climate Change, ERO, BBSR have accorded Stage-I approval vide their Letter F. No. 8(21)28/2003-FCE dated 04.03.2020 for diversion of 1.81 ha forest land in addition to the earlier diversion over 23.581 ha within the Mining Lease area of 28.397 ha in respect of Patabeda Iron Ore Mines of M/s MGM Minerals subject to fulfilment of twenty three (23) nos of conditions stipulated therein. The User Agency has complied all the conditions imposed by Govt. of India, MoEF & CC, ERO, BBSR. The point wise compliance basing on the reports of the DFO, Bonai Forest Division and RCCF, Rourkela Circle are as follows:-

(i) Legal status of the diverted forest land shall remain unchanged;

In compliance to the above, the User Agency has furnished an undertaking duly countersigned by DFO, Bonai Forest Division that the legal status of the forest land proposed for diversion shall remain unchanged which is enclosed at SI.No. 1 of Annexure-1.

(ii) Compensatory afforestation shall be raised over 1.81 ha of non-forest land identified in Khata No.132, Plot No.1155, Kisam Patharabani of village Phuljhar under Lahunipara Tahasil of Sundargarh district by the State Govt. at the cost of user agency. As far as practicable a mixture of local



indigenous species will be planted and monoculture of a species has to be avoided;

In compliance to the above, the RCCF, Rourkela Circle has reported that an extent of 1.81 ha of non-forest Govt. land has been identified in village Fuljhar under Lahunipara Tahasil of Bonai Forest Division in Sundargarh District and accordingly, the Compensatory Afforestation Scheme has been prepared over 1.81 ha of non-forest Govt. land by the DFO, Bonai Forest Division.

The said Compensatory Afforestation Scheme has been technically approved by the Addl. PCCF (FD & NO FC Act) for Rs 12,70,100/- at the wage rate of Rs 286.30/- per MD, for Rs 13,01,700/- at the wage rate of Rs 303.40/- per MD by the PCCF(FD & NO, FC Act, for Rs 13,10,100/- at wage rate of Rs 308/- per MD by the PCCF(FD & NO, FC Act) and for Rs 13,15,500/- at current wage rate of Rs 311/- per MD by the Addl.PCCF(FD & NO,FC Act). A copy of the said CA Scheme alongwith the financial outlay is enclosed as Annexure-2.

The user agency has deposited the total CA cost of Rs 13,15,500/- in two phases. In the first phase, the user agency has deposited Rs 13,10,100/- in State Specific CAMPA Account No.150825835900410 in Corporation Bank, Lodhi Complex Branch, Lodhi Road, New Delhi vide UTR No. SBINR52021020609959118 dated 06.02.2021. A copy of the payment intimation of DFO, Bonai division and payment receipts are enclosed as Annexure-2A & 2B respectively.

In the second phase, the user agency has deposited the differential cost of CA amounting to Rs 5400/- (Cost of CA for Rs 13,15,500/- @311/- per MD - Cost of CA for Rs 13,10,100/- @ Rs 308/- per MD) in State Specific CAMPA Account No.150825835900666 in Union Bank of India, Lodhi Complex Branch, Lodhi Road, New Delhi vide UTR No. SBIN421231205032 dated 19.08.2021. A copy of the payment intimation of DFO, Bonai division and payment receipts are enclosed as Annexure-3 & 3A respectively.

Planting of a mixture of local indigenous species has been included in the CA Scheme and monoculture of species has been avoided.

(iii) The non-forest land identified for raising compensatory afforestation shall be transferred and mutated in favour of the State Forest Department before issue of the Stage II approval.

In compliance to the above, the RCCF, Rourkela Circle has reported that the non-forest Govt. land over 1.81 ha identified in village Fuljhar under Lahunipara Tehsil of Bonai Forest Division has already been transferred and mutated in favour of Divisional Forest Officer, Bonai Division and RoR has been issued vide Khata No.133. A copy of the RoR is enclosed as **Annexure-4**.

Further, the draft notification proposal for declaration of non-forest Govt. land measuring 1.81 ha in village Fuljhar under Lahunipara Tehsil of Bonai Forest Division as

"Protected Forest" has already been communicated to the Govt. of Odisha, Forest, Environment and Climate Change Department vide this office Letter No. 13945 dated 17.08.2021. A copy of the said letter is enclosed as **Annexure-4A**.



(iv) The cost of Compensatory Afforestation at the prevailing wage rates as per Compensatory Afforestation Scheme and at the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for work schedule for subsequent year;

In compliance to the above, the RCCF, Rourkela Circle has reported that an extent of 1.81 ha of non-forest Govt. land has been identified in village Fuljhar under Lahunipara Tahasil of Bonai Forest Division in Sundargarh District and accordingly, the Compensatory Afforestation Scheme has been prepared over 1.81 ha of non-forest Govt. land by the DFO, Bonai Forest Division.

The said Compensatory Afforestation Scheme has been technically approved by the Addl. PCCF (FD & NO FC Act) for Rs 12,70,100/- at the wage rate of Rs 286.30/- per MD, for Rs 13,01,700/- at the wage rate of Rs 303.40/- per MD by the PCCF(FD & NO, FC Act, for Rs 13,10,100/- at wage rate of Rs 308/- per MD by the PCCF(FD & NO, FC Act) and for Rs 13,15,500/- at current wage rate of Rs 311/- per MD by the Addl.PCCF(FD & NO,FC Act). A copy of the said CA Scheme alongwith the financial outlay is enclosed as Annexure-2.

The user agency has deposited the total CA cost of Rs 13,15,500/- in two phases. In the first phase, the user agency has deposited Rs 13,10,100/- in State Specific CAMPA Account No.150825835900410 in Corporation Bank, Lodhi Complex Branch, Lodhi Road, New Delhi vide UTR No. SBINR52021020609959118 dated 06.02.2021. A copy of the demand notice of DFO, Bonai division and payment receipts are enclosed as Annexure-2A & 2B respectively.

In the second phase, the user agency has deposited the differential cost of CA amounting to Rs 5400/- (Cost of CA for Rs 13,15,500/- @311/- per MD - Cost of CA for Rs 13,10,100/- @ Rs 308/- per MD) in State Specific CAMPA Account No.150825835900666 in Union Bank of India, Lodhi Complex Branch, Lodhi Road, New Delhi vide UTR No. SBIN421231205032 dated 19.08.2021. A copy of the demand notice of DFO, Bonai division and payment receipts are enclosed as Annexure-3 & 3A respectively.

Planting of a mixture of local indigenous species has been included in the CA Scheme and monoculture of species has been avoided.

Further, the RCCF, Rourkela Circle has reported that the above C.A. Scheme over 1.81 ha has been technically approved by the Addl.PCCF(FD & NO, FC Act) with a financial outlay of Rs 13,15,500/- which includes Rs 7,00,709/- towards the cost of barbed wire fencing of 1019 RMT over the entire boundary of the CA area of 1.81 ha proposed for plantation. The approved cost includes cost of survey, demarcation and fixing of RCC pillars. The entire cost of CA has been deposited by the User Agency on dated 6.2.2021 and 19.8.2021. Further, the cost norm provided for Block Plantation @1600 plants per ha in the C.A. Scheme has a provision for 10 years maintenance. Besides, there is a provision of 20% escalation cost over the total cost of Block plantation and cost of barbed wire fencing which also includes appropriate provision for anticipated cost increase for works scheduled for subsequent years.

(v) State Government shall charge the Net Present Value (NPV) for 1.81 ha forest area to be diverted under this proposal, if not paid, from the user agency as per the Orders of the Hon'ble Supreme Court of India dated 30.10.2002, 01.08.2003, 28.03.2008, 24.04.2008 and 09.05.2008 in IA No.566 in Writ Petition (Civil) No.202/1995 and as per the guidelines issued by this Ministry vide letter No.5-1/1998-FC (Pt.II) dated 18.09.2003 as well as letter No.5-2/2006-FC dated 03.10.2006 and No.5-3/2007-FC dated 05.02.2009 in this regard;

In compliance to the above, the RCCF, Rourkela Circle has reported that the total forest area in the lease comes to **27.086 ha**. The details of NPV deposited by the user agency is furnished below-:

(i) As per demand Letter No. 3612 dated 16.08.2004 of DFO, Bonai Forest Division, the user agency has deposited Rs 1,36,76,980/- towards NPV over 23.581 ha of forest area @Rs 5.80 lakh per ha on 09.08.2005 which has been subsequently deposited in CAF A/c No. 1585 of Corporation Bank, Lodhi Road, New Delhi vide Demand Draft No. 095664 dated 14.06.2006 amounting to Rs 21,26,98,034/- (which includes the funds received from different user agencies towards deposit of compensatory levies during the Year 2005-06 in respect of Bonai Forest Division).

The demand letter of DFO, Bonai Forest Division, copy of DD No. 095664 dated 14.06.2006 amounting to Rs 21,26,98,034/- and the details of funds received from different user agencies towards deposit of compensatory levies during the Year 2005-06 in respect of Bonai Forest Division are enclosed as **Annexure-5, 5A & 5B** respectively.

(ii) As per demand Letter No. 2943 dated 05.06.2010 of DFO, Bonai Forest Division, the user agency has deposited **Rs 25,58,650/-** towards NPV over the balance forest area of **3.505** ha @Rs 7.30 lakh per ha vide **Demand Draft No. 018344 dated 03.07.2010** in CAF A/c No. 1585 of Corporation Bank, Lodhi Road, New Delhi.

The demand letter of DFO, Bonai Forest Division and a copy of DD No. 018344 dated 03.07.2010 amounting to Rs 25,58,650/- are enclosed as **Annexure-6 & 6A** respectively.

(iii)As per demand Letter No. 5122 dated 02.06.2020 of DFO, Bonai Forest Division, the user agency has deposited Rs 13,17,290/- which includes Rs 3,78,290/- towards differential NPV over 1.81 ha of forest land through online in State Specific CAMPA Account No.150825835900763 in Corporation Bank, Lodhi Complex Branch, Lodhi Road, New Delhi vide UTR No. SBINR52020070100111554 dated 01.07.2020.

The demand letter of DFO, Bonai Forest Division and a copy of the payment receipt are enclosed as **Annexure-7 & 7A** respectively.

Thus, in total, the User Agency has deposited **Rs 1,66,13,920/-** (Rs 1,36,76,980 + Rs 25,58,650 + Rs 3,78,290) towards NPV of entire forest area of **27.086 ha** in the lease.

(vi) Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Govt. from the User Agency. The user agency shall furnish an undertaking to this effect.

In compliance to the above, the User Agency has furnished an undertaking to pay the additional amount of NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India duly countersigned by the DFO, Bonai Forest Division which is enclosed at SI.No. 2 of Annexure-1.

(vii) All the funds received from the User Agency under the project shall be transferred/deposited to State CAMPA fund only through (https://parivesh.nic.in/).

In compliance to the above, the user agency has deposited the compensatory levies in shape of DDs as per the demand letter of DFO, Bonai Forest Division during 2006 and 2010.

All the dues thereafter have been transferred / deposited by the user agency in State CAMPA Fund only through online portal (https://parivesh.nic.in/). The details of compensatory levies deposited by M/s OMC Ltd. duly signed by the DFO, Bonai Forest division and countersigned by the Addl.PCCF(FD & NO, FC Act) in the prescribed format is enclosed as **Annexure-8**.

(viii) The user agency shall obtain prior approval of the Central Government under the Forest (Conservation) Act,1980 in respect of 1.695 ha of forest land, earmarked as safety zone out of total safety zone area of 1.886 ha, involved in the mining lease in accordance with the provisions of guidelines, as provided under para 7.9 of the Handbook of the Forest (Conservation) Act,1980.

In compliance to the above, the User Agency has submitted an undertaking duly countersigned by the DFO, Bonai Forest Division to obtain prior approval of the Central Government under the Forest (Conservation) Act,1980 in respect of 1.695 ha of forest land, earmarked as safety zone out of total safety zone area of 1.886 ha involved in the mining lease in accordance with the provisions of guidelines, as provided under the Para-7.9 of the Handbook of the Forest (Conservation) Act,1980 which is enclosed at S1.No. 3 of Annexure-1.

(ix) In accordance with the provisions given under Para 1.21 of the Handbook of the Forest (Conservation) Act, 1980, State Govt. shall realize NPV equal to twice the normal NPV, for violation of the conditions stipulated in the approval dated 30.12.2005, committed by using the forest area amounting to 0.50 ha for the purpose other than what was approved by the Central Govt.

In compliance to the above, the user agency has deposited Rs 13,17,290/- which includes Rs 9,39,000/- towards Penal NPV for violations committed over 0.50 ha of forest area as per demand Letter No. 5118 dated 02.06.2020 of DFO, Bonai Forest Division through online in State Specific CAMPA Account No.150825835900763 in Corporation Bank, Lodhi Complex Branch, Lodhi Road, New Delhi vide UTR No. SBINR52020070100111554 dated 01.07.2020. The demand letter of DFO, Bonai Forest Division and a copy of the payment receipt are enclosed as Annexure-8A & 7A respectively.

(x) Compliance of the condition stipulated in the Stage - II approval dated 30.12.2005 shall be examined and violation of conditions, if any, shall be dealt with as per provisions provided in Para 1.21 of the Forest (Conservation) Act, 1980 before considering the proposal for grant of Stage-II approval.

In compliance to the above, the compliance to the conditions stipulated in the approval issued vide Letter No.8 (21)28/2003-FCE dated 30.12.2005 of the GoI,MoEF,ERO, BBSR submitted by the User Agency and countersigned by the DFO, Bonai Forest Division is enclosed as **Annexure-9**.

(xi) The cost of felling of trees shall be deposited by the user agency with the State Forest Department.

In compliance to the above, the User Agency has submitted an undertaking duly countersigned by the DFO, Bonai Forest Division that the cost of felling of trees will be

deposited with the State Forest Department as per demand raised by the Forest Department which is enclosed at SI.No.4 of Annexure-1.

(xii) The user agency shall ensure demarcation of boundary of safety zone (7.5 meter strip all along the inner boundary of the mining lease area), and its protection by erecting adequate number of 6 feet RCC boundary pillars inscribed with DGPS coordinates with barbed wire fencing and deploying adequate number of watchers under the Supervision of the State Forest Department. Safety Zone shall be raised and maintained by the user agency/State Govt. in accordance with the relevant guidelines issued by the Ministry

In compliance to the above, the RCCF, Rourkela Circle has reported that the user agency has demarcated the boundary of 7.5 meters of safety zone all along the mine boundary by erecting 6 feet RCC pillars inscribed with DGPS co-ordinates with barbed wire fencing and provided adequate number of watch and ward for protection of the plantation as per the report of Range Officer, Koira.

Further, the DFO, Bonai has reported that in compliance to Condition No.7 of the earlier Stage-II approval granted vide Letter No.8 (21)28/2003-FCE dt.30.12.2005 of the GoI,MoEF, ERO, BBSR the Scheme for fencing, protection, re-generation and maintenance of Safety zone over 3.505 ha was approved vide Memo No.2043 dt. 26.5.2005 of the then C.F., Rourkela Circle. The User Agency has deposited Rs 2,53,000/- towards cost of Safety Zone, which has been subsequently deposited in CAF A/c No. 1585 of Corporation Bank, Lodhi Road, New Delhi vide **Demand Draft No. 095664 dated 14.06.2006** amounting to **Rs 21,26,98,034/-** (which includes the funds received from different user agencies towards deposit of compensatory levies during the Year 2005-06 in respect of Bonai Forest Division) which is already enclosed as **Annexure 5A & 5B**.

The DFO, Bonai Forest Division has also reported that the plantation and maintenance work has already been completed.

(xiii) The User agency shall obtain the Environment Clearance as per the provisions of the Environment (Protection)Act,1986, if required,

In compliance to the above, the User Agency has obtained Environmental Clearance vide Reference No. 7722/SEIAA dated 03.1.2020 of the State Environment Impact Assessment Authority (SEIAA) which is enclosed as **Annexure-10**. Further, the User Agency has also obtained Consent to Operate vide Letter No.2726/IND-I-CON-5427 dated 07.3.2020 of the SPCB, Odisha which is enclosed as **Annexure-11**. The validity of CTO is upto 31.03.2024.

(xiv) The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.

In compliance to the above, the Collector, Sundargarh has issued certificate under Forest Rights Act, 2006 over **27.086 ha** of the entire forest land on 19.09.2014 and the said FRA certificate has been communicated by the Addl.District Magistrate, Sundargarh

vide his Letter No.3186 dated 19.9.2014 addressed to the DFO, Bonai Forest Division which is enclosed as **Annexure-12**.

(xv) The Period of diversion of the said forest land under this approval shall be for a period co-terminus with the period of the mining lease to be granted under Mines and Minerals (Development and Regulation) Act,1957, or Rules framed there under.

In compliance to the above, the DFO, Bonai Forest Division has reported that the period of diversion of the said forest land under this approval will be co-terminus with the period of the mining lease to be granted under Mines & Minerals (Development & Regulation) Act, 1957 or Rules framed there under.

(xvi) No labour camp shall be established on the forest land.

In compliance to the above, the User Agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division not to establish labour camp on the forest land which is enclosed at **SI.No.6 of Annexure-1**.

(xvii) The user agency shall provide LPG to the labourers and the staff working at the site so as to avoid any damage and pressure on the adjacent forest land.

In compliance to the above, the User Agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division to provide LPG to the labourers and the staff working at the site so as to avoid any damage and pressure on the adjacent forest land which is enclosed at SI.No. 7 of Annexure-1.

(xviii) The user agency while executing works, shall not fell any tree or damage forest growth in the surrounding forest area in any manner.

In compliance to the above, the User Agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division not to fell any trees or damage forest growth in the surrounding forest area in any manner while executing works which is enclosed at SI.No. 8 of Annexure-1.

(xix) The layout plan of the proposed forest land shall not be changed without prior approval of Ministry of Environment, Forest & Climate Change.

In compliance to the above, the User Agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division not to change the layout plan of the proposed forest land without the prior approval of Ministry of Environment, Forest & Climate Change which is enclosed at SI.No.9 of Annexure-1.

(xx) The Forest land shall not be used for any purpose other than that specified in the proposal and under no circumstances be transferred to any other user agency, department or person without the prior approval of Ministry of Environment, Forest & Climate Change;

In compliance to the above, the User Agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division that the forest land shall not be used for any purpose other than that specified in the proposal and under no circumstances be transferred to any other user agency, department or person without the prior approval of Ministry of Environment, Forest & Climate Change which is enclosed at SI.No.10 of Annexure-1.

(xxi) Any other condition that the Regional Office (Eastern Zone), Bhubaneswar of this Ministry and State Government of Odisha may stipulate, from time to time, in the interest of conservation, protection and development of forests & wildlife, which shall be complied by the user agency;

In compliance to the above, the User Agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division to comply any other condition that the Regional Office (Eastern Zone), Bhubaneswar of this Ministry and State Government of Odisha to be stipulated from time to time, in the interest of conservation, protection and development of forests & wildlife which is enclosed at SI.No.11 of Annexure-1.

(xxii) The State Govt. and user agency shall ensure compliance to provisions of the all Acts, Rules, Regulations, Guidelines, NGT Order (s) & Hon'ble Court Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project;

In compliance to the above, the User Agency has furnished an undertaking duly countersigned by the DFO, Bonai Forest Division to comply the provisions of the all Acts, Rules, Regulations, Guidelines, NGT Order (s) & Hon'ble Court Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project which is enclosed at SI.No.12 of Annexure-1.
