With reference to this office letter No.2073 2.27.04.2021 it is to inform you that the Additional Principal Chief Conservator of Forests (FD & NO FC, Act) O/ o the Principal Chief Conservator of Forests, Odisha has technically approved the revised financial out lay of Rs.3,16,66,100/- (Rupees Three Crore Sixteen Lakhs Sixty Six Thousand one hundred) only towards the cost of compensatory Afforestation over 131.00 ha. in Lamra PRF under Sambalpur District against diversion of 65.4036 ha. of Forest Land for laying of underground Natural Gas Pipeline along with Optical Fibre Cable (OFC).
