विषयांतर्गत भारत सरकार, पर्यावरण, वन एवं जलवायु परिवर्तन मंत्रालय, क्षेत्रीय कार्यालय, नागपुर के संदर्भित पत्र - 1 द्वारा कोरबा जिले के कटघोरा वन मण्डल अन्तर्गत परियोजना निदेशक, भारतीय राष्ट्रीय राजमार्ग प्राधिकरण का मार्ग निर्माण के लिए रकबा 83.624 हे. वन भूमि के गैर वानिकी उपयोग हेतु सैद्धांतिक स्वीकृति प्रदान की गई है।
