**Demand Notice for differential CA & other charges**

Sub: Diversion of 15.981 ha of forest land in RM Block and other villages for Approach Road, Downhill Pipe Conveyor (DPC) and Feed & Transfer point area for Rama Iron Ore Mine (M.L.No.2621) in favour of M/s JSW Steel Ltd. Torangallu [Proposal No. FP/KA/Others/27780/2017 (Stage-I approved)].

With reference to the above subject, the Government of India and Government of Karnataka have accorded final (Stage-II) under Section-2 of Forest (Conservation), Act-1980 for diversion of 4.74 hectare of forest land in Donimalai Forest Block, Sandur Taluk, Sandur South Range, Ballari Division & District for use of existing approach road to MLNo. 0004(2366) in favour of M/s. JSW Steel Limited, Toranagallu vide letters under Ref(1) & (2).

In the light of approval accorded by the Government of Karnataka in their orders, the Principal Chief Conservator of Forests (Forest Conservation), Bengaluru has directed the Deputy Conservator of Forest, Ballari to execute an agreement with User Agency duly incorporating all the conditions imposed by the Government of India and Government of Karnataka **subject to payment of any recoverable balance in compliance of the condition of Stage-I & Stage-II(final) vide letter under Ref(3).**

Further, there is a revision in the CA charges [Common Sanctioned Schedule of Rates (CSSR) in the year 2024-25] notified. The differential charges for Raising of Avenue Plantation as applicable for the above referred proposal are calculated as here under;
