Sir,

With reference to the subject cited above, I am enclosing herewith the letter no MFG.22/D-RTSS/6254 dated 05/08/2022 received from Deputy Conservator of forest (FC Act) inform you that Government vide letter no FOR.28/2022/54 dated 04/08/2022 has conveyed its Stage I Approval for the Diversion of 0.08 Ha of Forest Land for providing additional water supply from Ka Riat Tynrah spring source to Block I, Block II and Block III, Lawsohtun Shillong (Copy of Stage -I approval enclosed).

In this regard I would like to request you to comply with the following conditions:-

- 1. As per point 3 of the Stage I approval, you shall pay the cost of raising Compensatory Afforestation amount to Rs 78194/- (Rupees Seventy Eight Thousand One Hundred Ninety Four only) and Net Present value (NPV) of Rs 1,14,934/- (Rupees One Lakhs Fourteen Thousand Nine Hundred and Thirty Four only) respectively by transferring / depositing into the CAMPA fund through e-portal (https://parivesh.nic.in/).
- 2. As per point no 9 of the Stage I approval, you shall transfer the cost of demarcation pillars of 80 numbers amounting to Rs 4,95,600/- (Rupees Four Lakhs Ninety Five Thousand Six Hundred only) respectively by cheque into the current A/c of The Divisional Forest Officer, East Khasi Hills & Ri-Bhoi (T) Division, Shillong, A/c No.30852745780.
- 3. Also, I am to instruct you to issue Compliance Report on all the conditions laid down in the Stage-I approval.
