**ITEM NO. - 6 To Authorise someone for signing and submitting the documents related to forest diversion proposal for diversion of forest land under the provisions of Forest (Conservation) Act, 1980 in respect of *Jumka Pathiriposhi Pahar Iron ore Block* of M/s Rungta Mines Limited located in the Sundargarh and Keonjhar District of Odisha**

The Chairman informed the Board that the Company had participated in auctions of mineral blocks conducted by the Government of Odisha against the Notice inviting Tender (NIT) dated 07.07.2021 and is declared "Preferred Bidder" under the provisions of Sub-Rule 9 (iii) of Rule 9 of Mineral (Auction) Rules, 2015 for the *Jumka Pathiriposhi Pahar Iron Ore Block* of Sundargarh and Keonjhar District in Odisha. As required under the provision of Rule 10(1) (a) of the Mineral (Auction) Rules, 2015, the Company has deposited 1<sup>st</sup> installment of the upfront payment for the said Iron Ore Block through online system of i3ms (Integrated Mines & Minerals Management System) of Steel Mines Department, Govt. of Odisha linked to the Heads of Accounts - "0853-Non-ferrous Mining and Metallurgical Industries-102-Mineral Concession Fees, Rents and Royalties" on 07.10.2021. Accordingly, the Company has been granted Letter of Intent (LOI) for the said Iron Ore Block for the grant of Mining lease under the provisions of Rule 10 (2) of the Mineral (Auction) Rules, 2015 as amended from time to time and as per the terms of the Tender document.

As per the terms of LOI, before grant of Mining lease for the aforesaid three Iron Ore Blocks, the Company is required to obtain necessary approvals/clearances like approval of Mining Plan, Environment Clearance & Forest Clearance etc. For this purpose someone is required to be authorized on behalf of the Company to represent, give undertaking, sign and submit all the necessary application and documents as required to be filed before the office of the Competent Authorities under the provisions of Forest (Conservation) Act, 1980 and the Rules and Guidelines framed thereunder for the purpose of grant of Forest Clearance in respect of the forest diversion proposal for diversion of forest land pertaining to the said *Jumka Pathiriposhi Pahar Iron Ore Block* of the Company located in the District Sundargarh and Keonjhar, Odisha.
