



POWER OF ATTORNEY

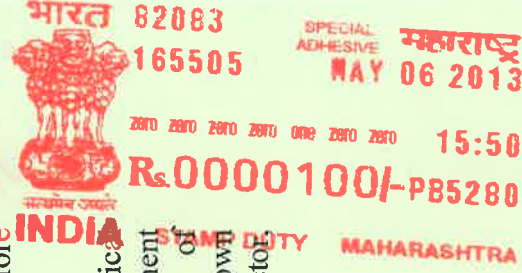

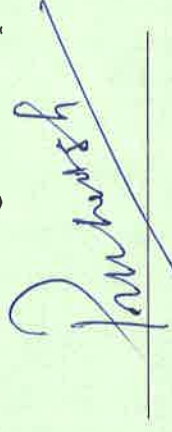
