The **Stage-I in-principle** approval order in connection with the above project has been issued vide No.5-ORC434/2020-BHU dt.03.11.2020 of the Government of India, MoEF& CC, ERO, Bhubaneswar with 26 conditions and additional 05 conditions has been imposed by the State Government vide No.FF-DIV-FLD-0041-2020-10F(Cons)155/2020-17699/F&E dt.11.11.2020 of the Government of Odisha, Forest & Environment Department which has been communicated to you vide Memo No.17703/F&E dt.11.11.2020 of the Special Secretary to Government, Forest & Environment Department which may be referred to.

As per Condition No.iii & iv in the **Stage-I in-principle** approval order, 25.00 Ha. of Degraded Forest Land has been identified in Pachhikote DPF under Jajpur Road Range of Cuttack Forest Division. Accordingly, the compensatory Afforestation scheme has been technically approved for Rs.48,96,200/- vide Memo No.20973 dt.02.12.2020 of Principal Chief Conservator of Forests (FD & NO, FC Act) O/o the Principal Chief Conservator of Forests, Odisha, Bhubaneswar.
